Virginia Tech, Fuente decide to part ways

Virginia Tech and head football coach Justin Fuente "mutually agreed to part ways" after six seasons, the school announced Tuesday.

The move comes days after the Hokies beat Duke 48-17 to run their record to 5-5 on the season. Fuente compiled a 43-31 record while at Tech.

Virginia Tech got off to a good start in 2021, upsetting then-No. 9 North Carolina in the season opener, but could never get on track, especially on the offensive end. The Hokies are ranked next to last in the Atlantic Coast Conference in scoring and total offense.

"We sincerely appreciate the contributions that Coach Fuente made to our football program and the positive impact he made on our student-

der for our football program to attain the type of sustained success that is expected at Virginia Tech, the time was right for new leadership of our football program."

Fuente took over for legendary coach Frank Beamer before the 2016 season and led the team to 10 victories, a division title and a bowl win in that first season - when he was named ACC Coach of the Year.

The Hokies never reached the ACC title game again during his tenure and lost three straight bowl games the next three seasons. Virginia Tech finished 5-6 last season.

According to the terms of his contract, Fuente will be owed a buyout of \$10 million. His contract is silent regarding a duty to mitigate.

Had Virginia Tech waited until at least Dec. 15 to make the move, the buyout would have dropped to \$7.5 million. Co-defensive line coach J.C. Price has been named interim coach. Virginia Tech has two games remaining against Miami and Virginia.

For those Texas A&M fans worried that head coach Jimbo Fisher might be jumping ship and pursuing other jobs, he says they have nothing to worry about.

Fisher spoke Monday about the speculation that he might leave College Station to take one of several jobs, including the opening at LSU, where he was an offensive assistant from 2000 to 2006.

The Aggies currently have a top-10 recruiting class for the 2022 season and just received a commitment from defensive tackle Walter Nolen, who is listed 6-foot-4 and 325 pounds, and have four other players who have committed that are in ESPN's top 100 high school recruits.
