

**EVIDENCE OF TRANSFER OF CLAIMS



Transferor further directs the Debtor, the Bankruptcy Court, and all other interested parties that all further notices relating to the foregoing claims, and all payments or distributions of money or property in respect of such claims, are to be delivered or made to Transferee.
