**MOTION TO ALLOW GEOFFREY S. GOODMAN  
TO APPEAR TELEPHONICALLY AT NOVEMBER 30, 2021 HEARING**

Ellen Arvin Kennedy, solely in her capacity as the Liquidating Trustee (the “**Liquidating Trustee**”) of the Cambrian Liquidating Trust (the “**Liquidating Trust**”), by and through its counsel, respectfully moves the Court (the “**Motion**”) for entry of an order permitting the Geoffrey S. Goodman (“**Mr. Goodman**”) to appear telephonically at the hearing scheduled for November 30, 2021 at 1:00 P.m. (the “**Hearing**”). In support of this Motion, the Liquidating Trustee respectfully states as follows:

The Hearing is currently scheduled for Tuesday, November 30, 2021 at 1:00 p.m. to consider the *Motion of the Liquidating Trustee for a Status Conference Regarding Transfer of Permits and for Shortened Notice* [ECF No. 1875] (the “**Status Conference Motion**”). The Trustee respectfully requests that Mr. Goodman be allowed to appear telephonically at the Hearing on the Status Conference Motion. Mr. Goodman is the counsel for the Trustee who is intimately familiar with the facts regarding this issue.
