AMENDED NOTICE OF HEARING ON MOTIONS FOR (I) FINAL DISTRIBUTION (II) AUTHORITY TO DESTROY BOOKS, RECORDS AND DOCUMENTS AND (III) ENTRY OF FINAL DECREE

PLEASE TAKE NOTICE that Clifford Zucker, the Plan Administrator (“Plan Administrator”) through undersigned counsel, filed a *Motion for an Order Authorizing Final Distribution to Holders of Allowed Class 5 CCG Unsecured Claim and Class 7 General Unsecured Claims Under the Confirmed Plan* [Dkt. 1221] (“Distribution Motion”) seeking the Court’s authority to make a final distribution of the Unsecured Distribution² to the holders of the Allowed Class 5 CCG Unsecured Claim and Class 7 General Unsecured Claims.

PLEASE TAKE FURTHER NOTICE the Plan Administrator simultaneously filed his *Motion for (I) Authority to Destroy Books, Records and Documents and (II) Entry of Final Decree* [Dkt. 1222] (collectively with the Distribution Motion, the “Motions”) seeking the Court’s authority to (i) destroy the Records, (ii) enter a final decree pursuant to 11 U.S.C. §350(a) in the Main Case, and (iii) grant such other general and equitable relief to which he may be entitled.

PLEASE TAKE FURTHER NOTICE that an expedited hearing on the Motions will be held on **December 14, 2021 at 10:00 a.m.**, before the Honorable Douglas S. Dodd, United States Bankruptcy Court, Eastern District of Louisiana, 707 Florida Street, Room 222, Baton Rouge, Louisiana 70801, via Video Conference. Please contact the Court for Zoom login and conference procedures (connect@lamb.uscourts.gov) at least three days prior to the hearing.

PLEASE TAKE FURTHER NOTICE that if you object to the relief requested in the Motions, you must file a written objection **no later than December 10, 2021**. You must serve a copy of your response on the person who sent you this notice. Otherwise, the Court may treat the Motions as unopposed and grant the relief requested.
