bankruptcy cases (the "<u>Trustee</u>"). After considering the Application and any responses thereto, the Court is of the opinion that it should be granted.

**IT IS, THEREFORE, ORDERED** that the total amount of \$527,227.93 in fees billed and expenses incurred by GDHM in the representation of the Trustee from November 1, 2020 through October 31, 2021 (the "<u>Application Period</u>") is hereby APPROVED on an interim basis.

**IT IS, FURTHERMORE, ORDERED** that GDHM is entitled to receive from the Trustee, and the Trustee is authorized to pay to GDHM, the balance of \$92,670.20 out of a total of \$527,227.93 in fees and expenses incurred during the Application Period, with credit given for the 434,557.73 in payments already made to GDHM in accordance with the Interim Compensation Procedures.

**IT IS, FURTHERMORE, ORDERED** that all fees and expenses paid to GDHM remain subject to disgorgement by future order of the Court in accordance with the provisions of the Bankruptcy Code and other governing law.
