ORDER APPROVING SECOND INTERIM AND FINAL APPLICATION FOR ALLOWANCE OF COMPENSATION AND REIMBURSEMENT OF EXPENSES OF DEBTORS' SPECIAL COUNSEL, ORR & RENO, P.A.

Upon consideration of the Second Interim and Final Application for Allowance of Compensation and Reimbursement of Expenses of Debtor's special counsel, Orr & Reno P.A. (the "Application"), and any objections thereto, for entry of an order a) on an interim basis, compensation for professional services performed by Orr & Reno PA for the Period from February 1, 2021 through April 30, 2021 (the "Second Interim Application Period") and b) final allowance and approval of compensation for professional services performed by Orr & Reno PA in the amount of \$24,858.00 (the "Total Requested Compensation") and reimbursement of expenses incurred by Orr & Reno PA in connection with such professional services in the amount of \$560.55 (the "Total Requested Expenses") for the period between October 20, 2020 through April 30, 2021 (the "Case Compensation Period"); and the Court, having reviewed the Application, and having found the Court has jurisdiction over this matter pursuant to 28 U.S.C. § 1334, this is a core matter pursuant to 28 U.S.C. § 157(b)(2), notice of the Application was sufficient under the circumstances and that no further notice need be given, and the legal and factual bases set forth in the Application establish just cause for the relief granted, hereby finds as follows:

IT IS HEREBY ORDERED,

- 1. The Application is approved in all respects.
- 2. Orr & Reno, P.A., as special counsel to Debtor HGRL in the above-captioned case, is hereby awarded for the period from February 1, 2021 through April 30, 2021 compensation in the amount of \$7,935.00 and reimbursement of expenses in the amount of \$379.95. This compensation and reimbursement constitute reasonable compensation for actual, necessary legal services rendered and expenses incurred in connection with those legal services during the Second Interim Compensation Period.
- 3. The fees of Orr & Reno PA in the amount of \$24,858.00 and reimbursement of expenses in the amount of \$560.55 are hereby allowed on a final basis as compensation for professional services and reimbursement of expenses during the Case Compensation Period.
- 4. To the extent not already paid, the Court authorizes the payment to Orr & Reno P.A. of the amounts set forth in Paragraph 3 as compensation for professional services and reimbursement of expenses rendered during the Case Compensation Period.
