**CERTIFICATION OF NO OBJECTION REGARDING THIRD MONTHLY FEE
STATEMENT OF FOX ROTHSCHILD LLP AS COUNSEL TO THE OFFICIAL
COMMITTEE OF UNSECURED CREDITORS OF ALUMINUM SHAPES L.L.C. FOR
THE PERIOD NOVEMBER 1, 2021 THROUGH NOVEMBER 30, 2021

MICHAEL J. VISCOUNT, JR., of full age, hereby certifies as follows:

1. I am an attorney-at-law in the State of New Jersey and a partner in the firm of Fox Rothschild LLP (“Fox Rothschild”), counsel to the Official Committee of Unsecured Creditors of Aluminum Shapes, L.L.C. (the “Committee”) in the above-captioned proceeding.
2. I submit this Certification pursuant to the Amended Administrative Fee Order Establishing Procedures for the Allowance and Payment of Interim Compensation and Reimbursement of Expenses to Professional Persons, entered on October 21, 2021 (the “Administrative Fee Order”) [Docket No. 193].

3. The Administrative Fee Order provides that each professional retained in this case pursuant to 11 U.S.C. § 327, and to the extent applicable, §§ 328 and 1103, may file monthly fee statements on or before the 25th day of each calendar month for interim approval and allowance of compensation for services rendered and reimbursement of expenses incurred during the immediately preceding month (the “Monthly Fee Statement”).

4. Pursuant to the Administrative Fee Order, an objection to a Monthly Fee Statement must be filed and served on the Professional filing such Monthly Fee Statement, as well as on the Notice Parties as defined therein, not later than fourteen (14) days after service of said Monthly Fee Statement (the “Objection Deadline”). Upon the expiration of the Objection Deadline, a Professional applying for fees may file a certification of no objection or certification of partial objection with the Court, as applicable, after which the Debtor is authorized to pay each Professional an amount equal to the lesser of: (i) eighty percent (80%) of the fees and one hundred (100%) percent of the expenses requested in the Monthly Fee Statement; or (ii) eighty (80%) percent of the fees and one hundred (100%) percent of the expenses not subject to an objection.

5. On December 10, 2021, Fox Rothschild filed its Second Monthly Fee Statement for the period November 1, 2021 through November 30, 2021 [Docket No. 317] (the “Third Monthly Fee Statement”). Pursuant to the Administrative Fee Order, objections to the Third Monthly Fee Statement were due by December 24, 2021.

6. To the best of my knowledge, information and belief, no objections have been filed to the Third Monthly Fee Statement.

7. Accordingly, the Debtor should be authorized to pay Fox Rothschild \$208,514.18 representing eighty (80%) percent of the fees and one hundred (100%) percent of the expenses requested in the Third Monthly Fee Statement.
