## **ORDERED, ADJUDGED, AND DECREED that:**

- 1. The Stipulation attached hereto as **Exhibit 1** is hereby approved.
- 2. Medline is authorized and entitled, in its sole discretion, to file a single, consolidated proof of claim (the "Consolidated Claim") in the Main Case against Gulf Coast Health Care, LLC.
- 3. The Consolidated Claim shall summarize Medline's prepetition claims against each of the applicable Debtors and shall be the only prepetition proof of claim required to be filed by Medline against the Debtors in the Chapter 11 Cases, subject to the right to amend or supplement the claim.
- 4. Nothing contained in the Stipulation shall constitute an admission or agreement by the Debtors with respect to the validity of the amounts or claims asserted in the Consolidated Claim or a waiver by the Debtors of any applicable objections or defenses to the claims asserted in the Consolidated Claim. The Debtors' rights with respect to any arguments, objections, or defenses related to the Consolidated Claim, other than any objection on the basis of Medline's filing of a Consolidated Claim, are hereby reserved.
- 5. The terms and provisions of this Stipulation shall be binding on the Parties' successors and assigns.
- 6. The Parties are authorized to take all actions necessary to effectuate the relief granted in this Order.

7. The Court retains exclusive jurisdiction with respect to all matters arising from or related to the implementation, interpretation, or enforcement of this Order.
