**PLEASE TAKE NOTICE** that the Plan Administrator,<sup>2</sup> Consumer Claims Trustee,<sup>3</sup> will present the *Stipulation Resolving Proof of Claim No. 24621* (the “**Stipulation**”) to the Honorable James L.

A copy of the Stipulation is attached to this Notice as Exhibit A. The Stipulation resolves Proof of Claim No. 24621 by allowing the claim in the amount of \$8,283.00 as a Class 6 Consumer Creditor Claim and that is not a 363(o) claim as defined by the Third Amended Plan.

**PLEASE TAKE FURTHER NOTICE** that unless a written objection to the Stipulation is served and filed with proof of service with the Clerk of the Court and a courtesy copy is delivered to the undersigned and to the Chambers of Judge Garrity so as to be received by Tuesday, January 18, 2022, at 4:00 PM EST, there will not be a hearing to consider the Stipulation, and the Court may approve the Stipulation.

**PLEASE TAKE FURTHER NOTICE** that if a written objection is timely filed and served with respect to the Stipulation, a hearing (the "**Hearing**") will be held to consider the Proposed Stipulation before Judge Garrity in the Courtroom at a date and time to be announced.

**PLEASE TAKE FURTHER NOTICE** that objecting parties are required to attend the Hearing, and failure to appear may result in relief being granted upon default.
