**CERTIFICATION OF COUNSEL REGARDING EIGHTEENTH

On December 10, 2021, the *Eighteenth Omnibus Objection of the Trustee of the Insys Liquidation Trust to Claims (Non-Substantive Objection)* [Docket No. 1778] (the “Objection”) was filed with the Court. Attached to the Objection as Exhibit A is a proposed form of order granting the Objection (the “Proposed Order”)

2. Responses, if any, to the Objection were required to have been filed with the Court and served no later than 4:00 p.m. on January 5, 2022 (the “Response Deadline”).

3. The undersigned certifies that he has reviewed the Court’s docket in this case and no answer, response or other responsive pleading to the Objection appears thereon.

4. Before the Response Deadline, counsel to the Trustee and counsel to claimants Stark County, OH Board of Commissioners and Montgomery County Board of Commissioners agreed to revise Exhibit 1 to the Proposed Order to modify their disallowed and surviving claims.

5. Accordingly, attached hereto as Exhibit A is the Proposed Order with revised Exhibit 1 (the “Revised Proposed Order”) reflecting the foregoing changes. No other changes to the Proposed Order or Exhibit 1 have been made.

WHEREFORE, the Trust respectfully requests the Court enter the Revised Proposed Order.
