Pursuant to the *Order Establishing Procedures for Interim Compensation and Reimbursement of Professional pursuant to Sections 105, 330, and 331 of the Bankruptcy Code* [Docket No. 296], the Debtors are authorized to pay the PCO a total payment of \$60,141.37, which includes \$58,302.00 in fees (such sum being equal to 80% of the \$72,877.50 in total fees reflected) and \$1,839.37 in out-of-pocket expenses.
