**NOTICE TO COUNTERPARTIES TO POTENTIALLY ASSUMED
EXECUTORY CONTRACTS AND UNEXPIRED LEASES REGARDING CURE
AMOUNTS AND POSSIBLE ASSIGNMENT TO THE STALKING HORSE BIDDERS
OR SUCH OTHER SUCCESSFUL BIDDERS AT AUCTION**

PLEASE TAKE NOTICE that on July 10, 2024, the above-captioned debtors and debtors in possession (the “**Debtors**”) filed an amended motion [Dkt. No. 67] (the “**Bid Procedures and Sale Motion**”) with the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”).

PLEASE TAKE FURTHER NOTICE that on July 26, 2024, the Bankruptcy Court entered an order [Docket No. 145] (the “**Bid Procedures Order**”), which (a) set key dates, times and procedures related to the sale (the “**Salt Life Sale**”) of the Debtors’ assets associated with the operation of the *Salt Life*® business (the “**Salt Life Assets**”) and the sale (the “**Non-SL Sale**” and, together with the Salt Life Sale, the “**Sales**”) of all or substantially all of the Debtors’ assets that are not associated with the operation of the *Salt Life*® business (the “**Non-SL Assets**” and, together with the Salt Life Assets, the “**Assets**”) pursuant to an auction (the “**Auction**”) overseen by the

Bankruptcy Court, which Auction is scheduled to occur on **August 27, 2024**, (b) authorized the Debtors to enter into a stalking horse asset purchase agreement (the “**Salt Life Stalking Horse Agreement**”) with FCM Saltwater Holdings, Inc., a Delaware corporation (the “**Salt Life Stalking Horse Bidder**”), and one or more stalking horse asset purchase agreements (each, a “**Non-SL Stalking Horse Agreement**” and, together with the Salt Life Stalking Horse Agreement, the “**Stalking Horse Agreements**”) with one or more stalking horse bidders (each, a “**Non-SL Stalking Horse Bidder**” and, together with the Salt Life Stalking Horse Bidder, the “**Stalking Horse Bidders**”), (c) established certain procedures relating to the Debtors’ assumption and assignment of executory contracts and unexpired leases in connection with each of the Sales, and (d) granted related relief.³ Approval of the Sales to the applicable Stalking Horse Bidders or such other applicable “Successful Bidders” (as defined in the Bid Procedures Order) after the results of the Auction and the Debtors’ assumption and assignment of any executory contracts and unexpired leases in connection therewith, is scheduled to take place at a hearing before the Bankruptcy Court at **2:00 p.m. (prevailing Eastern Time) on September 5, 2024** (the “**Sale Hearing**”). The Sale Hearing may be adjourned by the Bankruptcy Court or the Debtors without further notice other than such adjournment announced in open court or a notice of adjournment filed on the Bankruptcy Court’s docket.

PLEASE TAKE FURTHER NOTICE that, in accordance with the Bid Procedures Order, the Debtors may assume and assign the executory contract(s) and/or unexpired lease(s) to which you may be a counterparty to the applicable Stalking Horse Bidder or such other applicable Successful Bidder (or Backup Bidder) after the outcome of the Auction.

PLEASE TAKE FURTHER NOTICE that the Debtors have conducted a review of their books and records and have determined the cure amount for unpaid monetary obligations under such contract or lease is set forth in the right hand column on Appendix I (the “**Cure Amount**”). If you object to (a) the proposed assumption or disagree with the proposed Cure Amount or (b) object to the possible assignment of such executory contract(s) or unexpired lease(s) to the applicable Stalking Horse Bidder, **you must file an objection with the Bankruptcy Court no later than August 19, 2024, at 4:00 p.m. (prevailing Eastern Time) (the “Objection Deadline”)** and serve such objection on the following parties:⁴

Cure Amount or provision of adequate assurance of future performance and from asserting any additional cure or other amounts with respect to your contract(s) or lease(s), and the Debtors and the applicable Stalking Horse Bidder or the applicable Successful Bidder (as applicable) shall be entitled to rely solely upon the Cure Amount, (b) deemed to have consented to the assumption or assumption and assignment, and (c) forever barred and estopped from asserting or claiming defaults exist, that conditions to assignment must be satisfied under such contract(s) and/or lease(s) or that there is any objection or defense to the assumption and assignment of such contract(s) and/or lease(s).

Such Contract Counterparty may not use or disclose, except to representatives, attorneys, advisors and financing sources ("**Representatives**"), any confidential Adequate Assurance Information for any purpose other than: (a) evaluating whether adequate assurance of future performance as required under section 365(f)(2)(B) and, if applicable, section 365(b)(3) of the Bankruptcy Code has been provided; and (b) in support of any Contract Objection by such Contract Counterparty with respect to such Qualified Bidder's adequate assurance. Any such Contract Objection that includes confidential, non-public Adequate Assurance Information shall be filed under seal without the need to file a separate motion or obtain a further order of this Court pursuant to Local Rule 9018-1(d) as the Bid Procedures Order shall be deemed to grant the applicable Contract Counterparty permission to file such objection under seal; provided, however, the Contract Counterparty shall not be required to file its Contract Objection under seal if disclosure of such confidential, non-public Adequate Assurance Information is authorized by the Debtors and the applicable Qualified Bidder with respect to which the adequate assurance information pertains. Any Representative receiving Adequate Assurance Information shall be notified of and shall be deemed to be bound by the restrictions set forth in the Bid Procedures Order.
