**NOTICE OF INTENDED SALE OF SUBSTANTIALLY ALL OF
DEBTOR'S ASSETS , DEADLINE FOR SUBMITTING
OBJECTIONS AND HIGHER OFFERS AND HEARING DATE**

To Creditors and Parties in Interest:

PLEASE TAKE NOTICE that pursuant to 11 U.S.C. Section 363, Fed. R. Bankr. P. 2002(a)(2) and 6004, and MLBR 2002-5 and 6004-1 and pursuant to the *Order Approving Debtor's Motion for Order (A) Approving Sale Procedures, Including Break-Up Fee, for Proposed Sale of Substantially All of the Debtor's Assets; (B) Approving Form and Manner of Notice; (C) Scheduling a Hearing to Consider the Sale of Such Assets; and (D) Granting Related Relief* (Docket No. 57) (the "Sale Procedures Order"),¹ that Western Massachusetts Lifecare Corporation (the "Debtor") intends to sell substantially all of its assets (the "Assets").

PLEASE TAKE FURTHER NOTICE that the Debtor has received an offer to purchase the Assets in exchange for (a) a cash payment of \$2,750,000 payable to U.S. Bank;² (b) the assumption of the obligations with respect to the Bridge Loan, which shall be restructured in accordance with the Stalking Horse LOI; (c) the assumption of all of the Debtor's obligations and liabilities to its existing residents under each Resident and Care Agreement and Admission Agreement and the assumption of all of the Debtor's refund obligations, if any, to any former resident party to a Resident and Care Agreement, which obligations and liabilities were estimated to be equal to approximately \$15,700,000 in the aggregate as of March 31, 2009 (the "Resident Obligations"); and (d) the assumption of the Ground Lease, which shall be restructured in accordance with the Stalking Horse LOI (the "Stalking Horse Bid"), from a newly-formed company sponsored by Loomis Communities, Inc. (the "Stalking Horse Bidder").

¹ All capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Sale Procedures Order. This Notice is qualified in its entirety by the Sale Procedures Order. All persons and entities are urged to read the Sale Procedures Order and the provisions thereof carefully. To the extent this Notice is inconsistent with the Sale Procedures Order, the terms of the Sale Procedures Order shall govern.

² Such payment shall be without prejudice to the right of any statutory committee appointed in this chapter 11 case, or the right of any other person or entity, to assert claims and defenses against U.S. Bank as set forth in any order approving the use of cash collateral entered in this chapter 11 case.

The Debtor and the Stalking Horse Bidder have entered into a letter of intent dated May 1, 2009 (the "Stalking Horse LOI"). The Stalking Horse LOI is the product of extensive negotiations by and between the Debtor and the Stalking Horse Bidder. The relationship between the Debtor and the Stalking Horse Bidder is arms-length. The Debtor and the Stalking Horse Bidder currently are negotiating a definitive asset purchase agreement (the "Stalking Horse Agreement"). The Debtor will file the Stalking Horse Agreement with the Bankruptcy Court no later than thirty (30) days prior to the Bid Deadline (as defined below).

PLEASE TAKE FURTHER NOTICE that the Stalking Horse Bidder has paid a deposit in the sum of \$100,000. The terms of the proposed sale are more particularly described in the *Motion for Order, Inter Alia, (A) Approving the Sale of Substantially All of the Debtor's Assets to a Designee of Loomis Communities, Inc. or Such Other Winning Bidder Free and Clear of all Liens, Claims, Interests and Encumbrances; (B) Approving and Authorizing the Assumption and Assignment of Certain Contracts, and (C) Granting Related Relief* (the "Motion to Approve Sale"), filed with the Court on May 4, 2009, and the Stalking Horse LOI.

PLEASE TAKE FURTHER NOTICE that the Assets will be sold free and clear of all liens, claims and encumbrances asserted against the assets of the Debtors, except as expressly provided in the Stalking Horse LOI and the Stalking Horse Agreement. Any perfected, enforceable valid liens shall attach to the proceeds of the sale according to priorities established under applicable law, except as otherwise provided for in the Stalking Horse LOI.

PLEASE TAKE FURTHER NOTICE that pursuant to the Sale Procedures Order, the Debtor intends to solicit higher and better offers for the Assets. A party wishing to submit a higher and better offer for the Assets must comply with the Sale Procedures as set forth in the Sale Procedures Order. If no Qualified Bid (other than the Stalking Horse Bid) is received on or before **Tuesday, July 21, 2009, at 5:00 p.m. (prevailing Eastern time)** (the "Bid Deadline"), the Debtor shall seek the Bankruptcy Court's approval of the Stalking Horse Agreement at the Sale Hearing (defined below).

PLEASE TAKE FURTHER NOTICE that if at least one Qualified Bid has been received by the Bid Deadline, the Debtor shall conduct an auction (the "Auction") on **Tuesday, July 28, 2009, at 10:00 a.m. (prevailing Eastern time)** at the United States Bankruptcy Court for the District of Massachusetts (Western Division), United States Courthouse, 300 State Street, Berkshire Courtroom, Third Floor, Springfield, Massachusetts 01105-2925 (the "Bankruptcy Court"), or at such other date and time as the Debtor establishes after consulting with the Pre-Petition Secured Creditors and the Creditors' Committee and with the approval of the Bankruptcy Court. The Auction may be adjourned from time to time as the Debtor determines in its discretion after consulting with the Pre-Petition Secured Creditors and the Creditors' Committee. Only Qualified Bidders will be eligible to participate at the Auction.

PLEASE TAKE FURTHER NOTICE that any objections to the sale and/or higher offers must be filed in writing with the Clerk of the Bankruptcy Court on or before **Tuesday, July 21, 2009, at 5:00 p.m. (prevailing Eastern time)**. Any objections to the entry of the Sale Order must (a) be in writing; (b) comply with the Federal Rules of Bankruptcy Procedure, including Fed. R. Bankr. P. 9014 and the Local Bankruptcy Rules of the United States Bankruptcy Court for the District of Massachusetts; (c) set forth the name of the objecting party,

Any party who has filed an objection is expected to be present at the hearing, failing which the objection will be overruled. If no objection to the Motion to Approve Sale or higher offer is timely filed, the Bankruptcy Court, in its discretion, may cancel the scheduled hearing and approve the sale without hearing.
