**SIXTH ORDER GRANTING LIMITED RELIEF  
FROM THE AUTOMATIC STAY TO LIQUIDATE BUT NOT OTHERWISE  
COLLECT OR ENFORCE A MEDICAL MALPRACTICE CLAIM WITH  
RESPECT TO THE MOTIONS IDENTIFIED ON THE ATTACHED  
EXHIBITS A AND B SEEKING RELIEF FROM THE AUTOMATIC STAY**

On August 18, 2006 and October 11, 2006, the United States Bankruptcy Court for the Southern District of New York (the “Court”) entered orders (the “August 18 Order” and the “October 11 Order,” respectively, and, together, the “Initial Lift Stay Orders”) (Dkt. Nos. 2038 and 2285) (i) granting limited relief from the automatic stay of section 362(a) of title 11, United States Code, to those medical malpractice claimants (“Medical Malpractice Claimants”) listed on Exhibit “A” to the Initial Lift Stay Orders, who had filed motions for relief from the automatic stay, to pursue claims for alleged medical malpractice against Saint Vincents Catholic Medical Centers of New York d/b/a Saint Vincents Catholic Medical Centers (“SVCMC”), one of the debtors and debtors in possession in the above-captioned Chapter 11 cases (collectively, the “Debtors”), and (ii) adjourning to subsequent status conferences the motions by those Medical Malpractice Claimants listed on Exhibit “B” to the Initial Lift Stay Orders. The Initial Lift Stay Orders are incorporated herein by reference.

At a status conference held on November 16, 2006 (the “November Status Conference”), the Debtors and the Tort Claimants’ Committee requested that this Court grant relief from the automatic stay for all of the motions listed on the revised Exhibits “A” and “B.” The revised exhibits had been updated to reflect recently filed motions for relief from the automatic stay. To the extent necessary, the record of the November Status Conference is incorporated herein by reference.

Subsequently, on November 21, 2006, this Court entered an order granting relief from the automatic stay for all of the motions listed on the revised Exhibit “A” and the motions included on the revised Exhibit “B” attached thereto (the “November 21 Order”) (Dkt. No. 2437).

At a status conference on December 14, 2006 (the “December 14 Status Conference”), the Debtors informed the Court of their intent to include eight (8) additional motions for relief from the automatic stay on further revised Exhibits “A” and “B,” as appropriate. On December 20, 2006, the Court entered an order reflecting the eight (8) additional motions on such updated Exhibits “A” and “B” (the “December 20 Order”) (Dkt. No. 2550).

At a status conference on January 24, 2007 (the “January 24 Status Conference”), the Debtors submitted further revised Exhibits “A” and “B” reflecting twenty-two (22) additional motions for relief from the automatic stay, as appropriate. On January 24, 2007, the Court entered an order reflecting the twenty-two (22) additional motions on such updated Exhibits “A” and “B” (the “January 24 Order,” and, together with the August 18 Order, the October 11 Order, the November 21 Order, and the December 20 Order, the “Lift Stay Orders”)(Dkt. No. 2690).

Since the January 24 Status Conference, the Debtors have become aware of twenty additional motions for relief from the automatic stay (Dkt. Nos. 652, 1452, 2670, 2671 (2672), 2702 (2744), 2705, 2706, 2732 (2736, 2737), 2642, 2644, 2746, 2747, 2748, 2749, 2753, 2755 (2800), 2759, 2771, 2789, and one (1) undocketed, *i.e.*, the motion Rafael Orozco) (collectively, the “Sixth Order – Lift Stay Motions”).<sup>1</sup> The Debtors reviewed each of the Sixth Order – Lift Stay motions to determine whether they should be characterized as Exhibit “A” or Exhibit “B.” At a status conference on February 21, 2007 (the “February 21 Status Conference,” together with the November Status Conference, the December 14 Status Conference, and the January 24 Status Conference, the “Status Conferences”), the Debtors informed the Court of their intent to include the Sixth Order – Lift Stay Motions on further revised Exhibits “A” and “B,” as appropriate. The attached Exhibits “A” and “B” reflect this characterization.

With respect to the Sixth Order – Lift Stay Motions, the Court **FINDS** as follows:

1. This Court has jurisdiction to consider the Sixth Order – Lift Stay Motions and the relief requested therein, pursuant to 28 U.S.C. §§ 157 and 1334 and the Standing Order of Referral of Cases to Bankruptcy Court Judges of the District Court for the Southern District of New York, entered July 11, 1984 (Ward, Acting C.J.).
2. Consideration of the Sixth Order – Lift Stay Motions and the relief requested is a core proceeding, pursuant to 28 U.S.C. § 157(b).
3. Venue is proper before this Court pursuant to 28 U.S.C. §§ 1408

and 1409.

4. Due and proper notice of the Sixth Order – Lift Stay Motions and the February 21 Status Conference was provided, and no other or further notice need be provided or hearing held before the Court renders its order with respect to the Sixth Order – Lift Stay Motions.

5. Sections 105(a) and 362 of the Bankruptcy Code provide the statutory predicates for the relief granted herein.

6. For the reasons set forth at the Status Conferences, which are incorporated herein by reference, and having reviewed the Sixth Order – Lift Stay Motions, the relevant responses to the Sixth Order – Lift Stay Motions (where applicable), and having considered the arguments and presentations of counsel at the February 21 Status Conference (where applicable), due cause exists to grant limited relief from the automatic stay consistent with the August 18 Order and the November 21 Order (to the extent applicable) for all motions listed on the attached, revised cumulative Exhibits “A” and “B.”

NOW, THEREFORE, IT IS HEREBY **ORDERED** that:

A. By this order (the “Sixth Lift Stay Order”), the automatic stay of section 362(a) is hereby modified solely to permit those actions identified on the revised Exhibits “A” and “B” to be liquidated in state court in accordance with the terms and conditions of the August 18 Order.

B. The injunction put into place for House Staff by the August 18 Order is hereby lifted with respect to any motions identified on the revised Exhibits “A” and “B” solely to allow medical malpractice claimants with claims against the House

Staff to liquidate their claims in accordance with the terms and conditions of the August 18 Order. The Debtors will defend House Staff in any such action consistent with past practice and ordinary course.

C. All other terms, conditions and procedures set forth in the Lift Stay Orders shall continue in full force and effect.
