**FIRST AMENDED NOTICE OF MODIFICATION
OF THE AUTOMATIC STAY AND PLAN INJUNCTION**

**THIS NOTICE CONCERNS THE STATUTE OF LIMITATIONS FOR
ACTIONS BY HOLDERS OF TIMELY FILED GENERAL LIABILITY
AND MEDMAL CLAIMS. ALL HOLDERS OF GENERAL LIABILITY
AND MEDMAL CLAIMS SHOULD READ THIS NOTICE AND THE
ATTACHED ORDER IN THEIR ENTIRETY. THE ORDER CONTAINS
EXHIBITS IDENTIFYING WHETHER THIS NOTICE RELATES TO
YOU AND YOUR CLAIM.**

NOTICE IS HEREBY GIVEN as follows:

Introduction

1. On July 27, 2007, the United States Bankruptcy Court for the Southern District of New York (the “Court”) entered an order (see Docket No. 3490) confirming plans of reorganization and liquidation in the above-captioned cases (collectively, the “Plan”), which generally provide for the reorganization of Saint Vincents Catholic Medical Centers of New York d/b/a Saint Vincent Catholic Medical Centers (“SVCMC”) and liquidation of its affiliated debtors (together with SVCMC, the “Post-Effective Date Debtors”). The Plan became effective on August 30, 2007. See Docket No. 3638.

2. Section 108(c) of the Bankruptcy Code provides, in relevant part, that:

if applicable nonbankruptcy law, an order entered in a nonbankruptcy proceeding, or an agreement fixes a period for commencing or continuing a civil action in a court other than a bankruptcy court on a claim against the debtor, ... and such period has not expired before the date of the filing of the petition, then such period does not expire until the later of –

(1) the end of such period, including any suspension of such period occurring on or after the commencement of the case; or

(2) 30 days after notice of the termination or expiration of the stay under section 362 .. of this title, ... with respect to such claim.

MedMal Claims

3. Pursuant to Article XI of the Plan, as of August 30, 2007, the automatic stay under section 362 of the Bankruptcy Code (the “Stay”) and the injunction provided for in the Plan (the “Plan Injunction”) were modified to allow holders of timely-filed MedMal Claims (as defined in the Plan) to commence or continue actions based on those claims in courts of competent jurisdiction other than the Bankruptcy Court, to proceed to settlement or judgment, and to collect on those claims pursuant to the terms of the Plan without further order of the Court.

General Liability Claims

4. On November 30, 2007, the Court entered an order (the “Order”), which became effective immediately, modifying the Stay and the Plan Injunction to allow holders of timely-filed prepetition personal injury or wrongful death claims *not* based on alleged medical malpractice that have not been disallowed (the “General Liability Claims”) to commence or continue actions based on those claims, to proceed to settlement or judgment in a court of competent jurisdiction other than the Bankruptcy Court and, to the extent the General Liability Claims are liquidated as to amount and liability pursuant to a final judgment or settlement, and after recovering on account of those claims from any of the Debtors’ available third party insurance policies, to be paid on those claims pursuant to the terms of the Plan without further order of the Court. A copy of the Order is attached to this Notice as Exhibit A.

General

5. The Order authorizes and directs the Post-Effective Date Debtors to serve notice of the Order on the parties listed on Exhibits 1 and 2 thereto (the “Modification Notice”) within ten (10) business days after entry of the Order. The Post-Effective Date Debtors served the Modification Notice on or about December 3, 2007.

6. The Order also provides that the Post-Effective Date Debtors may amend Exhibits 1 and 2 to the Order, and requires that the Post-Effective Date Debtor file with the Court and serve on an affected party a copy of the amended exhibits. Once filed and served, these amended exhibits have the same effect as the exhibits attached to the Order when it was entered. The Post-Effective Date Debtors have amended Exhibits 1 and 2 (the “First Amended Exhibits”) to

add additional parties (shown in **bold** on the First Amended Exhibits). The First Amended Exhibits are attached to this Notice as Exhibit B. The First Amended Exhibits reflect the holders of timely filed MedMal Claims and the holders of timely filed General Liability Claims, respectively, as of December 11, 2007. If you are identified in **bold** as the holder of a timely filed MedMal Claim or General Liability Claim on the First Amended Exhibits, this Notice applies to you.¹ Please note that these Exhibits are subject to further amendment by the Post-Effective Date Debtors, upon notice to the Court and to the affected parties, as provided in the Order.

**ORDER MODIFYING THE STAY AND PLAN INJUNCTION
WITH RESPECT TO CERTAIN PERSONAL INJURY CLAIMS
AND APPROVING THE FORM OF NOTICE OF MODIFICATION**

Upon the motion, dated November 19, 2007 (the “Motion”) of reorganized Saint Vincents Catholic Medical Centers of New York d/b/a Saint Vincent Catholic Medical Centers (“SVCMC”) and its affiliates (collectively with SVCMC, the “Post-Effective Date Debtors”) pursuant to sections 105, 108, and 362 of title 11 of the United States Code (the “Bankruptcy Code”) for entry of an order (i) modifying the automatic stay imposed by section 362 of the Bankruptcy Code (the “Stay”) and the injunction (the “Plan Injunction”) contained in the Post-Effective Date Debtors’ confirmed plans of reorganization and liquidation (the “Plan”) to allow holders of timely-filed prepetition personal injury or wrongful death claims *not* based on alleged medical malpractice that have not been disallowed (the “General Liability Claims”) (a) to commence or continue actions based on those claims, (b) to proceed to Final Judgment (as defined below) or settlement and, (c) once a General Liability Claim is liquidated in amount either by settlement or Final Judgment, and after recovering on account of such liquidated claim from the Debtors’ third party insurance policies, to collect on the unpaid amount of the claim as an “Allowed Claim” pursuant to the terms of and as defined in the Plan, without further order of the Bankruptcy Court; and (ii) approving the form of notice of modification of the Stay and the

Plan Injunction attached to the Motion as Exhibit “B” (the “Modification Notice”) to be sent to holders of MedMal Claims (as defined in the Plan) identified on Exhibit “1” to this Order and to holders of General Liability Claims identified on Exhibit “2” to this Order, all as more fully set forth in the Motion; and this Court having jurisdiction to consider the Motion and the relief requested therein pursuant to 28 U.S.C. §§ 157 and 1334 and Article X of the Plan; and consideration of the Motion and the relief requested therein being a core proceeding pursuant to 28 U.S.C. § 157(b); and venue being proper before this Court pursuant to 28 U.S.C. §§ 1408 and 1409; and due and proper notice of the Motion having been provided to all parties entitled to receive notice pursuant to Rule 4001 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), Rule 4001-1 of the Local Rules of the Bankruptcy Court for the Southern District of New York (the “Local Rules”), and this Court’s Order Establishing Certain Notice, Case Management and Administrative Procedures, entered July 12, 2005; and it appearing that no other or further notice need be provided; and the relief requested in the Motion being in the best interests of the Post-Effective Date Debtors and their estates and creditors; and this Court having reviewed the Motion; and this Court having determined that the legal and factual bases set forth in the Motion establish just cause for the relief granted herein; and upon all of the proceedings had before this Court and after due deliberation and sufficient cause appearing therefor, IT IS HEREBY ORDERED, ADJUDGED, AND DECREED THAT:

1. The Motion is granted to the extent provided in this Order.
2. As used in this Order, “Final Judgment” means a judgment or order of a court of competent jurisdiction over a General Liability Claim other than the Bankruptcy Court as to which the time to appeal, petition for certiorari, or move for reargument or rehearing has expired and as to which no appeal, petition for certiorari, or motion for reargument or

rehearing shall then be pending or as to which any right to appeal, petition for certiorari, or move to reargue or rehear shall have been waived in writing in form and substance satisfactory to the Post-Effective Date Debtors or, in the event that an appeal, writ of certiorari, or reargument or rehearing thereof has been sought, such judgment or order shall have been upheld by the highest court to which such order was appealed, or from which certiorari, reargument or rehearing was sought and the time to take any further appeal, petition for certiorari or move for reargument or rehearing shall have expired; provided, however, the possibility that a timely motion under Federal Rule of Civil Procedure 24 or any applicable analogous rule may be filed with respect to such order shall not prevent such judgment or order from being a Final Judgment.

3. The Motion is hereby deemed to be a timely-interposed objection to each General Liability Claim that has not been Allowed as of the date of this Order, sufficient to make such claim “Disputed” under the Plan.
4. The Stay and the Plan Injunction are modified to allow holders of the General Liability Claims listed on Exhibit 2 to this Order (a) to commence or continue actions based on those claims, (b) to proceed to settlement or Final Judgment and, (c) once a General Liability Claim is liquidated in amount either by settlement or Final Judgment, and after recovering on account of such liquidated claim from the Debtors’ third party insurance policies, to collect on the unpaid amount of the claim as an Allowed Class 3 Claim pursuant to the terms of and as defined in the Plan, without further order of the Bankruptcy Court.
5. This Order shall take effect immediately upon entry, notwithstanding Bankruptcy Rule 4001.

6. Within ten (10) business days after entry of this Order, the Post-Effective Date Debtors shall serve a copy of the Modification Notice and this Order on each party included in the lists attached to this Order as Exhibits 1 and 2.
7. The Post-Effective Date Debtors may file with this Court and serve upon any party affected by such amendment, amended Exhibits 1 and 2 to this Order. Such amended exhibits will have the same effect upon filing and service as if they had been the exhibits attached to the Motion when it was initially filed and to this Order when it was entered.
8. The Modification Notice is approved. Service of the Modification Notice satisfies section 108(c) of the Bankruptcy Code as to any party on which the Modification Notice is served.
9. Any and all objections to the Motion or the relief requested therein that have not been withdrawn, waived, or settled, and all reservations of rights included in such objections, are hereby overruled on the merits with prejudice.
10. The requirement pursuant to Local Rule 9013-1(b) that the Post-Effective Date Debtors file a memorandum of law in support of the Motion is hereby waived.
