

PLEASE TAKE NOTICE that:

1. By order entered on July 22, 2009 (the “**Approval Order**”), the United States Bankruptcy Court for the Southern District of New York (the “**Court**”) approved the Disclosure Statement filed by Frontier Airlines Holdings, Inc. and those of its subsidiaries that are debtors and debtors in possession (collectively, the “**Debtors**”) and directed the Debtors to solicit votes to accept or reject the Debtors’ Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code (as the same may be updated, supplemented, amended and/or otherwise modified from time to time, the “**Plan**”),<sup>2</sup> annexed as Exhibit A thereto.

2. The Approval Order establishes **July 22, 2009** as the Record Date for determining the holders of pre-chapter 11 claims entitled to vote on the Plan and establishes **4:00 p.m. (prevailing Eastern Time) on August 28, 2009** as the Voting Deadline for the submission of ballots to accept or reject the Plan (the “**Ballots**”).

3. Holders of claims entitled to vote on the Plan will receive electronic copies on CD-ROM of (i) the Approval Order, the Disclosure Statement, the Plan and certain exhibits thereto, (ii) this notice, (iii) if applicable, a letter from the statutory committee of unsecured creditors (the “**Creditors’ Committee**”) regarding acceptance of the Plan and (iv) a Ballot or Beneficial Ballot, as appropriate, together with a pre-addressed postage pre-paid envelope to be used by you in voting to accept or to reject the Plan. Failure to follow the instructions set forth on the Ballot or Beneficial Ballot, as applicable, may disqualify that Ballot or Beneficial Ballot and the vote represented thereby.

4. If you received electronic copies of the Disclosure Statement and the Plan and would like to receive paper copies, please visit the Debtors’ case information website (located at [www.frontier-restructuring.com](http://www.frontier-restructuring.com)), or contact the Debtors’ Solicitation Agent, Epiq Bankruptcy Solutions, LLC, at 646-282-2400.

5. Holders of (i) unimpaired claims and (ii) claims or interests that will receive no distribution under the Plan are not entitled to vote on the Plan and, therefore, will receive a notice of non-voting status rather than a Ballot. If you have not received a Ballot (or you have received a Ballot in an amount you believe to be incorrect) but believe that you should be entitled to vote on the Plan (or vote in an amount different than the amount listed on your Ballot), then you must serve on the Debtors and the Creditors’ Committee and file with the Bankruptcy Court a motion for an order pursuant to Bankruptcy

Rule 3018(a) (a “**Rule 3018(a) Motion**”) temporarily allowing such claim in a different amount for purposes of voting to accept or reject the Plan on or before the fourteenth (14th) day after the later of (i) the date that the Debtors complete distribution of the Solicitation Packages and (ii) the date of service of an objection, if any, to such claim. In accordance with Bankruptcy Rule 3018, as to any creditor filing a Rule 3018(a) Motion, such creditor’s Ballot will not be counted unless temporarily allowed by the Bankruptcy Court for voting purposes after notice and a hearing. Rule 3018(a) Motions that are not timely filed and served in the manner as set forth above may not be considered.

6. A hearing will be held before the Honorable Robert D. Drain, United States Bankruptcy Judge at the United States Bankruptcy Court, One Bowling Green, New York, New York,<sup>3</sup> on **September 10, 2009 at 10:00 a.m. (prevailing Eastern Time)** or as soon thereafter as counsel may be heard (the “**Confirmation Hearing**”) to consider the entry of an order confirming the Plan. The Confirmation Hearing may be continued from time to time without further notice other than a notice filed on the Court’s docket or an announcement by the Debtors of the adjourned date(s) at the Confirmation Hearing or any continued hearing, and the Plan may be modified, if necessary, pursuant to section 1127 of the Bankruptcy Code, prior to, during or as a result of the Confirmation Hearing, without further notice to interested parties.

7. Objections, if any, to the Plan must be in writing, must conform to the Federal Rules of Bankruptcy Procedure and the Local Rules of the Bankruptcy Court and shall be filed with the Bankruptcy Court electronically in accordance with the Bankruptcy Court’s Order Establishing Certain Notice, Case Management and Administrative Procedures entered May 2, 2008 (the “**Case Management Order**”) and served **so as to be actually received on or before 4:00 p.m. (prevailing Eastern Time) on August 28, 2009** by (i) the United States Bankruptcy Court for the Southern District of New York, One Bowling Green, New York, NY 10004-1408,<sup>4</sup> Attn: Honorable Robert D. Drain; (ii) counsel to the Debtors, Davis Polk & Wardwell LLP, 450 Lexington Avenue, New York, NY 10017, Attn: Marshall S. On April 10, 2008, Frontier Airlines Holdings, Inc. and its two subsidiaries (collectively, the “**Debtors**”) filed voluntary cases under chapter 11 of the United States Bankruptcy Code (the “**Cases**”).

On July 22, 2009, the bankruptcy court overseeing the Cases entered an order (the “**Approval Order**”) approving, among other things, the Disclosure Statement (the “**Disclosure Statement**”) for the Debtors’ Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code (the “**Plan**”). Entry of the Approval Order is a critical milestone toward the Debtors’ planned emergence from chapter 11.

**COMMUNICATION FROM THE STATUTORY COMMITTEE OF  
UNSECURED CREDITORS OF FRONTIER AIRLINES HOLDINGS, INC.,  
ET AL.:**

The Statutory Committee of Unsecured Creditors (“Committee”) of Frontier Airlines Holdings, Inc. and certain of its subsidiaries and affiliates (collectively, “Frontier” or the “Debtors”) has reviewed the Disclosure Statement for Debtors’ Joint Plan of Reorganization Under Chapter 11 of the Bankruptcy Code (the “Plan”), engaged in extensive discussions with the Debtors, and considered the recovery scenarios to unsecured creditors contemplated under the Plan. Based on the foregoing, the Committee believes the proposed treatment under the Plan constitutes the best recovery for unsecured creditors under the circumstances.

**For the reasons stated above, the Committee endorses the Plan and recommends that the Holders of Allowed Class 3 Claims (the only class entitled to vote on the Joint Plan) vote to accept the Plan and return their ballot indicating such acceptance in accordance with the voting instructions set forth on the ballot.** Notwithstanding the Committee’s recommendation, each Holder of Class 3 Claims (including individual members of the Committee) must make its own independent decision as to whether or not the Plan is acceptable to that creditor and should consult with its own legal and/or financial advisor(s) before voting to accept or reject the Plan.
