

NOTICE OF MOTION OF THE DEBTORS FOR (I) AN ORDER
(A) APPROVING BIDDING PROCEDURES FOR THE AUCTION OF ASSETS RELATED TO THE DEBTORS' CERTIFIED HOME HEALTH AGENCY,
(B) SCHEDULING AN AUCTION AND SALE HEARING RELATED THERETO,
(C) APPROVING NOTICE OF THE AUCTION AND SALE HEARING, AND (D) APPROVING PROCEDURES FOR THE ASSUMPTION AND ASSIGNMENT OF CERTAIN EXECUTORY CONTRACTS AND UNEXPIRED LEASES RELATED THERETO; AND (II) AN ORDER (A) APPROVING SUCH SALE FREE AND CLEAR OF LIENS, CLAIMS, ENCUMBRANCES AND OTHER INTERESTS AND (B) AUTHORIZING PAYMENT OF THE BROKERS' TRANSACTION FEE

PLEASE TAKE NOTICE OF THE FOLLOWING:

1. <u>Introduction</u>. On June 30, 2010, Saint Vincents Catholic Medical Centers of New York ("<u>SVCMC</u>") and certain of its affiliates, as chapter 11 debtors and debtors in possession (collectively, the "<u>Debtors</u>") in the above-referenced chapter 11 cases (the "<u>Chapter 11 Cases</u>"), filed a motion (the "<u>Motion</u>") for (i) an order (the "<u>Bidding Procedures Order</u>"),

(a) approving bidding procedures (the "Bidding Procedures") for the auction (the "Auction") of certain of the assets related to Debtors' certified home health agency, (the "CHHA," or the "Assets"); (b) scheduling the Auction and a hearing approving the sale of the Assets (the "Sale Hearing"); (c) approving the form and manner of the notice of the Auction and Sale Hearing (the "Auction and Sale Hearing Notice"); and (d) approving certain procedures for the assumption and assignment of certain executory contracts and unexpired leases (the "Assumed Contracts and Leases") related to the Assets (the "Assignment Procedures"); and (ii) an order (the "Sale Order"), (a) approving a sale of the Assets free and clear of liens, claims, encumbrances and other interests to North Shore University Hospital, a New York not-for-profit corporation ("North Shore" or the "Purchaser") or another bidder submitting a higher or otherwise better offer at the Auction (the "Sale Transaction"), and (b) authorizing the payment of the brokers' Transaction Fee (as defined below) in connection with the Sale Transaction. The Debtors and North Shore have entered into an Asset Purchase Agreement, dated June 28, 2010 (the "APA"), for the Sale of the Assets, but pursuant to the proposed Bidding Procedures, the Sale of the Assets remains subject to competing offers from a qualified prospective bidder.

2. <u>Important Dates</u>. Pursuant to the Motion, the Debtors have requested approval of the following relevant dates for the Auction and approval of a Sale Transaction:

- 3. <u>Bidding Procedures Hearing.</u> A hearing on the requested Bidding Procedures is scheduled for **July 22, 2010 at 11:00 a.m.** (prevailing Eastern Time), before the Honorable Cecelia G. Morris, United States Bankruptcy Judge, in Courtroom 701 at the United States Bankruptcy Court for the Southern District of New York, Alexander Hamilton Custom House, One Bowling Green, New York, New York 10004-1408. At the Bidding Procedures hearing, the Debtors will request that the Bankruptcy Court enter an order approving the proposed Bidding Procedures and schedule the Auction to take place on August 10, 2010 (or such later date as may be scheduled by the Debtors).
- 4. Objections to the Bidding Procedures. Objections, if any, to the Bidding Procedures shall: (i) be in writing; (ii) specify with particularity the basis of the objection; and (iii) be filed with the Court and simultaneously served on the following parties (the "Notice Parties"): (a) Debtors' counsel, Kramer Levin Naftalis & Frankel LLP, 1177 Avenue of the Americas, New York, New York 10036, Attn: Adam C. Rogoff, Esq. and Stephen Zide, Esq.; (b) counsel for the Committee, c/o Akin Gump Strauss Hauer & Feld LLP, One Bryant Park, New York, New York 10036, Attn: David Botter, Esq., Stephen Kuhn, Esq. and Kenneth Davis, Esq.; (c) General Electric Capital Corporation, as Agent for itself and TD Bank, N.A., c/o Winston & Strawn LLP, 200 Park Avenue, New York, New York, 10166-4193, Attn: David Neier; and Winston & Strawn LLP, 101 California Street, San Francisco, CA 94111-5802, Attn: Randy Rogers, Esq.; (d) the Office of the United States Trustee for the Southern District of New York, 33 Whitehall Street, 21st Floor, New York, New York 10004, Attn: Serene Nakano, Esq.; and (e) counsel to North Shore, Kelley Drye & Warren LLP, 101 Park Avenue, New York, NY 10178, Attn: W. Christian Drewes, so as to be actually received by 4:00 p.m. (prevailing Eastern Time) on July 12, 2010 (the "Bidding Procedures Objection Deadline").
- 5. <u>Auction</u>. In the event that the Debtors receive a bid for the Assets, the Debtors intend to conduct the Auction with respect to the Assets. The Auction will take place at the offices of Kramer Levin Naftalis & Frankel LLP, 1177 Avenue of the Americas, New York, New York 10036 on August 10, 2010, starting at 9:00 a.m. (prevailing Eastern Time), or at such other place, date and time as may be designated by the Debtors at or prior to the Auction.
- 6. <u>Sale Hearing</u>. The Sale Hearing is scheduled for **August 19, 2010 at 11:00 a.m.** (**prevailing Eastern Time**), before the Honorable Cecelia G. Morris, United States Bankruptcy Judge, in Courtroom 701 at the United States Bankruptcy Court for the Southern District of New York, Alexander Hamilton Custom House, One Bowling Green, New York, New York 10004-1408. At the Sale Hearing, the Debtors will request that the Bankruptcy Court enter an order approving the Sale of the Assets to the prevailing bidder of the Auction.
- 7. Objections to the Sale. Objections, if any, to the Sale shall: (i) be in writing; (ii) specify with particularity the basis of the objection; and (iii) be filed with the Court and simultaneously served on the Notice Parties, the Successful Bidder (as determined in the Auction), and the Backup Bidder (as determined in the Auction), so as to be actually received by 4:00 p.m. (prevailing Eastern Time) on August 5, 2010 (the "Sale Objection Deadline"). Only in the event that the Debtors choose a Successful Bidder other than North Shore at the Auction, the Sale Objection Deadline solely with respect to the Debtors' choice of such alternative Successful Bidder will be 4:00 p.m. (prevailing Eastern Time) on August 13, 2010

(the "<u>Supplemental Objection Deadline</u>"). The Supplemental Objection Deadline is NOT an opportunity to file a late Objection to the Motion and the objection must be limited to objections concerning the Successful Bidder if not North Shore. In addition, in the event that the Successful Bidder designates any additional Assumed Contracts and Leases, any objection to such assumption and assignment must be received by the Supplemental Objection Deadline.


