UNITED STATES BANKRUPTCY JUDGE:

1. On April 11, 2011, the Court entered the Order approving certain claims objection procedures and settlement procedures under sections 105 of the Bankruptcy Code and Bankruptcy Rules 3007 and 9019(b) [Docket No. 1552] (the "**Claims Objection and Settlement Procedures Order**").¹

2. In compliance with the Claims Objection and Settlement Procedures Order, to date, the Debtors have mailed approximately 1352 letters (the "**Informal Objection Letters**") to the holders of approximately 1275 claims outlining potential grounds for objection and

proposing a resolution of the claim(s) addressed in the letter. Attached to each Informal Objection Letter was a form soliciting the recipient's consent to the resolution proposed by the Debtors.

3. Section I(3) of the Claims Objection and Settlement Procedures requires the Debtors to file periodic reports disclosing the resolution agreed to by each accepting claimant as indicated on the Consent Form.

4. On May 16, 2011, the Debtors filed their First Notice of Consensually Resolved Claims [Docket Number 1621].

5. On July 29, 2011, the Debtors filed their Second Notice of Consensually Resolved Claims [Docket Number 1863].

6. Between the filing of the prior notice and the date of this notice (the "**Notice Period**"), the debtors have received 199 consent forms in response to the Informal Resolution Letters. Attached as **Exhibit A** is a report listing each of the claims that have been resolved in response to an Informal Objection Letter during the Notice Period, together with the key terms of the resolutions. The Debtors' Claims Agent has marked the Claims Register to reflect these resolutions.

7. Attached as **Exhibit B** is a report listing each of the claims which have been satisfied or released in full, by payments, credits, and/or settlements made after the commencement of these chapter 11 cases in accordance with title 11 of the United States Code (the "**Bankruptcy Code**"), applicable rules, an order of the United States Bankruptcy Court for the Southern District of New York (the "**Court**"). The Debtors' Claims Agent has marked the Claims Register to reflect these resolutions.
