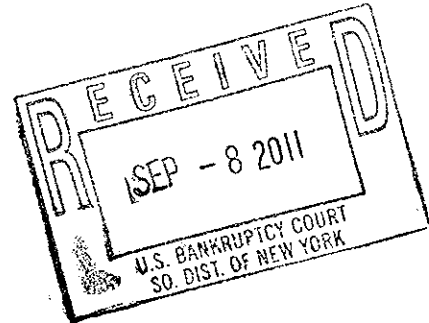



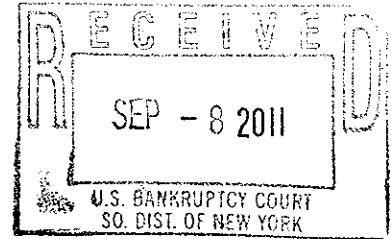

Court deposes and states as follows:

1. I am an associate at the law firm Dealy & Silberstein, LLP, the attorneys for Approved Oil Company of Brooklyn, Inc. ("Approved Oil").
2. I submit the instant Affidavit in response to the Ninth Omnibus Objection of Saint Vincents Catholic Medical Centers of New York and its affiliated debtors (the "Debtors") Seeking to Disallow Certain Late Filed Claims.
3. Approved Oil is a domestic business corporation with its principal place of business located at 6741 5th Avenue, Brooklyn, New York 11220.
4. Approved Oil sold and delivered goods, specifically fuel oil, to Debtors prior to

Debtors' filing of a voluntary petition for relief under Chapter 11 of the Bankruptcy Code on or about April 14, 2010.

5. As of Debtors' filing for relief under Chapter 11 of the Bankruptcy Code on or about April 14, 2010, Debtors were indebted to Approved Oil in the amount of Thirty-One Thousand Five Hundred and Ten Dollars and Thirteen Cents (\$31, 510.13).
6. Upon information and belief, Approved Oil timely filed Proof of Claim No. 4309 (the "Claim") on or about April 18, 2010 in the amount of Thirty-One Thousand Five Hundred and Ten Dollars and Thirteen Cents (\$31, 510.13) for the outstanding balance owed by Debtors to Approved Oil for fuel oil.
7. Based upon the foregoing, Approved Oil believes that it has timely filed its Claim, and accordingly, it objects to Debtors' attempt to disallow its Claim.
