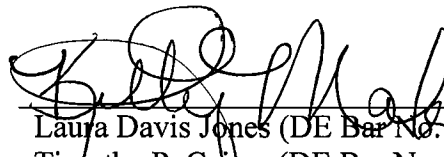
SECOND SUPPLEMENTAL NOTICE OF ORDINARY COURSE PROFESSIONALS
