



## **EXHIBIT A**

### About the Purchaser

Sundae Group Holdings II, LLC (together with its direct and indirect wholly-owned subsidiaries, “Purchaser”) will be a newly formed entity under the laws of the State of Delaware and owned 100% (directly or indirectly) by affiliates of the current equity owners of the Debtors, all of which (other than two *de minimis* minority investors) are affiliates of Sun Capital Partners, Inc. (“Sun Capital”). Sun Capital is a leading private investment firm focused on leveraged buyouts, equity, debt, and other investments in market-leading companies in a wide range of industries including, paper and packaging, food and beverages, metals and mining, automotive after-market parts, consumer products, financial services, healthcare, media and communications, building products, telecommunications, technology, retailing and catalogs, restaurants, manufacturing and industrial, among others. Sun Capital has offices in Boca Raton, Los Angeles and New York, and affiliates in London, Frankfurt, Paris, Luxembourg, Shanghai and Shenzhen.

Since its inception in 1995, Sun Capital has invested in 280 companies worldwide. Sun Capital’s current portfolio includes 10 restaurant chains. Purchaser will operate the Friendly’s business as a going concern and in a substantially similar manner and use as the existing use today.

Sun Capital has approximately \$8 billion of capital under management. Sun Capital is prepared to provide the capital necessary for the proposed asset purchase and the immediate working capital needs of Purchaser. In addition, Purchaser expects to have access to debt to ensure it has sufficient liquidity to operate the business.

### Management Team Experience

As has already been disclosed in these Cases, affiliates of Sun Capital are the current owners of a majority equity interest in the Debtors and have ample experience and familiarity with the Debtors’ financial condition, businesses, and various vendor- and landlord-parties, which is invaluable to the future success of Purchaser. In addition, it is Purchaser’s intention to offer employment to the Debtors’ current management team, which members include, among others, the current CEO and other members of the senior executive team.

### Future Performance and Use

The leases and contracts will be assumed and assigned in full with no changes thereto, except for any changes that counterparties may agree to in writing on a consensual basis. Thus, all existing rights of counterparties to the leases and contracts will remain unchanged and Purchaser will operate the business in accordance with the terms of the existing agreements. The existing leases and contracts to be assumed will be assigned to Purchaser, which, at closing, will own substantially all of the same assets of the business currently owned by the Debtors (other than assets specifically not to be purchased), including the inventory, the leasehold premises and lease rights, the cash, the equipment, fixtures, furniture, machinery, franchise rights and intellectual property. In addition to owning substantially the same assets, Purchaser intends to make offers of employment to all or nearly all of the Debtors’ same employees following the

asset purchase. Accordingly, Purchaser's employees, management and equity owners will continue to have familiarity with the operation of the restaurant, franchising and other businesses and first-hand knowledge of the leased premises. Moreover, as discussed above, the ultimate ownership of Purchaser will continue unchanged.

With respect to real estate leases, Purchaser will continue to operate and use the leased premises in the manner as they are currently being used – as a Friendly's restaurant – and Purchaser will comply with all provisions of the existing leases that it assumes going forward, including use clauses and exclusivity provisions.

The post-acquisition balance sheet of Purchaser will be much stronger than the existing financial condition of the Debtors because Purchaser will have substantially all of the same assets but with much less of the existing debt or other liabilities. Purchaser will also be adequately capitalized with a combination of new equity and availability under new borrowings, and will continue to generate cash flow from its operations. These three sources of capital (equity, debt funding and cash flow from operations) will be more than "adequate" to cover all required payments under the leases and contracts.
