#### PLEASE TAKE NOTICE THAT:

- 1. On April 14, 2010, Saint Vincents Catholic Medical Centers of New York and certain of its affiliates, as Chapter 11 debtors and debtors in possession (collectively, the "**<u>Debtors</u>**")<sup>1</sup> filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code, in the United States Bankruptcy Court for the Southern District of New York.
- 2. On April 24, 2012, the Debtors filed the Debtors' Joint Chapter 11 Plan (the "<u>Plan</u>") [Docket No. 2848] and the accompanying disclosure statement (the "<u>Disclosure Statement</u>") [Docket No. 2847].

- 3. On May 14, 2012, the Debtors filed an amended Plan (as amended, the "<u>Amended Plan</u>") [Docket No. 2898] and an amended Disclosure Statement (as, amended, the "<u>Disclosure Statement</u>") [Docket No. 2897], reflecting certain amendments and modifications that the Debtors made to the original documents.
- 4. On May 18, 2012, the Debtors filed a further amended Plan (as amended, the further "<u>Amended Plan</u>") [Docket No. 2921] and a further amended Disclosure Statement (as amended, the further "<u>Amended Disclosure Statement</u>") [Docket No. 2920], reflecting certain amendments and modifications that the Debtors made to the original documents.
- 5. On June 21, 2012, the Debtors filed a further amended Plan (as amended, the "Second Amended Plan") [Docket No. 3035], reflecting certain technical amendments to the Second Amended Plan to reflect following changes: (i) the timing of filing of Plan Supplements; (ii) certain conforming changes to the Plan based upon the Liquidating Trust Agreement; (iii) a modification of the Effective Date of the employees that will continue to provide services to the Post-Effective Date SVCMC to be each individual's last day of employment; (iv) clarification that the Post-Effective Date SVCMC will be making Cash Settlement Claim distributions (directly or through a third party disbursement agent); (v) clarification of Causes of Action preserved; (vi) clarification of the effect of the injunction provisions regarding the assertion of valid rights of setoff and recoupment; (vii) clarifying additional duties of the Post-Effective Date SVCMC with respect to winding down the affairs of the non-Debtor affiliates; (viii) providing that after the Effective Date, the Post-Effective Date SVCMC and its employees, agents and professionals are authorized to provide assistance and service to the Liquidating Trustee in the performance of his duties under the Plan and (ix) minor technical revisions.
- 6. Employees, 1199SEIU Hospital League Health Care Industry Labor Management Initiative, Inc. and the League/1199SEIU Health Care Industry Job Security Fund;
