Statutory priority amounts for employee claims have been (a) reduced to the extent such employee received payment for prepetition wages on a postpetition basis and (b) capped by the value of terminal benefits accrued during the 180 days immediately preceding the Petition Date subject to the \$11,725 statutory cap set forth in section 507 of the Bankruptcy Code. Listing a claim on Schedule E as "priority" does not constitute an admission by the Debtors that such claim is entitled to priority under section 507 of the Bankruptcy Code, or of the legal rights of the claimant or a waiver of the Debtors' right to recharacterize or reclassify such claim or contract.
