**NOTICE OF ADJOURNMENT WITH RESPECT TO CERTAIN CLAIMS  
SUBJECT TO THE FIFTY-FOURTH OMNIBUS OBJECTION OF THE  
LIQUIDATING TRUSTEE TO CERTAIN CLAIMS**

**PLEASE TAKE NOTICE** that the hearing on the *Fifty-Fourth Omnibus Objection of the Liquidating Trustee to Certain Claims (Tier I—(A) Improperly Classified Claims, (B) Claim Amounts that Are Inconsistent with the Debtors’ Books and Records, and (C) Claims Lacking Sufficient Documentation)* [Docket No. 3428] (the “**Fifty-Fourth Omnibus Objection**”), which is scheduled to be heard on May 16, 2013, has been adjourned solely with respect to certain claims.<sup>2</sup> Specifically, the

**PLEASE TAKE FURTHER NOTICE** that the deadline for parties in interest to respond to the Fifty-Fourth Omnibus Objection with respect to those claims listed on **Exhibit A** has been extended to **June 13, 2013 at 5:00 p.m. (prevailing Eastern Time)**. Additionally, the deadline for parties in interest to respond to the Fifty-Fourth Omnibus Objection with respect to those claims listed on **Exhibit B** has been extended to **September 12, 2013 at 5:00 p.m. (prevailing Eastern Time)**.
