B. Every Response Must Contain, at a Minimum, the Following Information:

- (a) a caption setting forth your name, the claim number at issue, and the title of the specific objection to which the Response is directed;
- (b) a concise statement specifically setting forth the reasons why the claim should not be disallowed or reduced as set forth in the objection, including, the specific factual and/or legal basis in support of the Response;
- (c) all documentation or other evidence of the claim, to the extent not previously included with the filed claim, upon which you will rely in opposing the objection;
- (d) the mailing address(es), if different from the one contained in the filed claim, to which the Receiver must return any reply to the response;

- (e) your telephone number and/or email address; and
- (f) the name, address, and telephone number of the person possessing ultimate authority to reconcile, settle, or otherwise resolve the claim objection with the Receiver, if you do not have ultimate authority to resolve this objection with the Receiver.

If no Response to the Fourth Omnibus Objection is timely received, the Court may grant the Fourth Omnibus Objection and enter the corresponding order reducing the amount of your claim without a hearing.

Gordon, the Court-appointed Receiver in the above captioned matter (the "Receiver"), by and through his counsel, Clark Hill PLC, objects (the "Fourth Omnibus Objection") to each of the claims listed on Exhibit "A" attached hereto (the "Overstated Claims"), pursuant to the Court's Order Approving the Motion of the Receiver For An Order Approving (i) Claim Procedures, (ii) Claim Form, (iii) Claim Bar Date, and (iv) Form and Manner of Notice Thereof (the "Claim Procedures Order") [Doc. No. 219]. Claimants receiving

this Fourth Omnibus Objection (collectively, the "Claimants" and, individually, a "Claimant") should locate their names and claims on Exhibit "A" attached hereto.

Background

1. On May 5, 2008, the United States Securities and Exchange Commission (the "SEC") filed its *Complaint* against Defendants Gregory N. McKnight ("McKnight") and Legisi Holdings, LLC (referred to collectively with Legisi Marketing, Inc. as "Legisi"), and Relief Defendants, Jennifer McKnight, Theresa Burton, Danielle Burton, Legisi Marketing, Inc, Lindenwood Enterprises, LLC, Healthy Body Nutraceuticals, and Lido Consulting, LLC, alleging, among other things, violations of various federal securities laws.

2. In its *Complaint*, the SEC alleges that Defendant McKnight, through his control of Legisi, raised approximately \$72 million from investors in violation of federal securities laws. It is further alleged that McKnight and Legisi invested approximately \$33 million of such funds in various investments such as foreign currencies, commodity futures, shares and warrants in thinly-traded over-the-counter ("OTC") stocks, in one privately-held company, and in one real estate investment partnership. Concurrently, the SEC also filed its *Motion for Preliminary Injunction* and its *Ex Parte Motion for the Appointment of a Receiver*.

3. On May 5, 2008, the Court entered its *Order Appointing Receiver* (the "Receiver Order"), appointing Robert D. Gordon as Receiver for the estate of Gregory N. McKnight and the estates of every corporation, partnership, trust and/or other entity which is directly or indirectly owned by or under the direct or indirect control of McKnight (the "Receivership Estates").

4. Pursuant to the Receiver Order, the Receiver has a number of powers and duties in administering the Receivership Estates. Among other things, the Receiver is responsible for(i) taking custody, control and possession of all funds, property, premises, leases, and other

assets of or in the possession or under control of the Receivership Estates; (ii) managing, controlling, and operating the Receivership Estates; and (iii) making distributions from the funds taken into his custody, control, and possession.

The Claim Procedures Order and the Objection Procedures Order

5. On August 31, 2009, the Court entered the Claim Procedures Order which (among other things) set December 15, 2009 as the date by which all claims must be filed or be forever barred from receiving any distribution from the Receivership Estates (the "Bar Date").

6. On February 9, 2011, the Court entered its *Order Granting Receiver's Motion to Establish Claim Objection Procedures* (the "Objection Procedures Order"), which expanded on the Claim Procedures Order, provided procedures to be used for claims objections and responses thereto, and granted the Receiver authority to settle such objections without further order of the Court.

7. Pursuant to the Claim Procedures Order and the Objection Procedures Order, the Receiver is empowered to file this Fourth Omnibus Objection to the Overstated Claims.

Relief Requested

8. Pursuant to this Fourth Omnibus Objection, the Receiver seeks entry of an order, substantially in the form attached hereto as <u>Exhibit "B"</u>, reducing the amount of each of the Overstated Claims as set forth on <u>Exhibit "A."</u>

Basis for Relief

9. As a result of the Receiver's review of the proofs of claim filed by claimants in this case and records in the Receiver's possession regarding Legisi's E-bullion and E-Gold

account activities,¹ the Receiver has identified the Overstated Claims as claims asserted in an amount greater than (i) the amount of the given claim according to the Receiver's books and records, or (ii) the amount of the claim supported by documentation, if any, submitted along with the proof of claim. By this Objection, the Receiver seeks to reduce each of the Overstated Claims to an amount less than the amount claimed by the Claimant.

10. In instances where a claim amount is not supported by the Receiver's books and records, but sufficient information was submitted with the proof of claim to support the amount claimed in full, the Receiver has not objected to the claim.

11. Failure to reduce the amount of the Overstated Claims may otherwise result in the applicable Claimants receiving an unwarranted recovery from the Receivership Estates to the detriment of holders of allowed claims for the proper amount.

12. It is well established that the Court has broad discretion in determining relief in an equity receivership. SEC v. Lincoln Thrift Ass'n, 577 F.2d 600, 606 (9th Cir. 1978) ("The district court has broad powers and wide discretion to determine the appropriate relief in an equity receivership.") As noted by the United States Court of Appeals for the Ninth Circuit, "reasonable administrative procedures, crafted to deal with the complex circumstances of each case, will be upheld. A district judge simply cannot effectively and successfully supervise a receivership and protect the interests of its beneficiaries absent broad discretionary power." SEC v. Hardy, 803 F.2d 1034, 1038 (9th Cir. 1986).

13. In addition, by filing their proof of claim forms, the holders of the Overstated Claims have consented to this Court's jurisdiction to determine the validity and amounts of their

claims. As set forth in the *Motion of the Receiver For An Order Approving (i) Claim Procedures, (ii) Claim Form, (iii) Claim Bar Date, and (iv) Form and Manner of Notice Thereof* [Doc. No. 213], which was granted in full by the Claim Procedures Order, by filing a proof of claim form, a claimant submits to this Court's jurisdiction for all purposes, including a determination as to the validity and amount of its claim against the Receivership Estates. The instructions provided to claimants with the proof of claim forms specifically advised claimants of this effect of filing a claim.

<u>Notice</u>

14. The Receiver will serve a copy of this Fourth Omnibus Objection and the attached exhibit, along with a notice apprising the Claimant of the procedure for disputing the relief requested herein, by first class mail, postage prepaid, upon each holder of an Overstated Claim at the address listed on the corresponding proof of claim form. A copy of the Fourth Omnibus Objection has also been filed with the CM/ECF system, which will serve a copy of this pleading on all attorneys registered to receive such filings. The Receiver submits that under the circumstances, no other or further notice is required.

Reservation of Rights

15. The Receiver expressly reserves the right to amend, modify or supplement the Fourth Omnibus Objection and to file additional objections to any of the claims which are subject to the Fourth Omnibus Objection.
