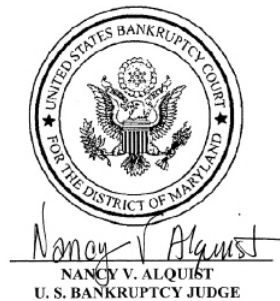

**ORDER APPROVING EIGHTEENTH APPLICATION OF
CO-COUNSEL TO THE OFFICIAL UNSECURED CREDITORS'
COMMITTEE FOR INTERIM COMPENSATION
AND REIMBURSEMENT OF EXPENSES**
