AND NOW, this 22nd day of June, 2017, upon consideration of the following:

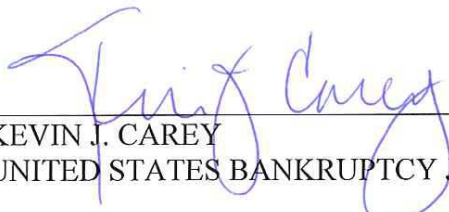
(a) Bimbo BBU USA, Inc.'s ("BBU") Memorandum of Law in Support of its Motion for the Allowance and Payment of Administrative Expenses Under 11 U.S.C. § 503(b)(9) and in Opposition to the Debtors' Objection to Such Claim (the "BBU Motion") (D.I. 2691); (b) the Debtor AW Liquidation, Inc.'s (f/k/a Associated Wholesalers, Inc.) ("AWI") Motion for Summary Judgment Pursuant to Fed. R. Civ. P. 56 (Made Applicable by Fed. R. Bankr. P. 7056 and 9014) With Respect to Bimbo Bakeries USA, Inc.'s Motion for the Allowance and Payment of Administrative Expenses under 11 U.S.C. § 503(b)(9) ("AWI's Motion for Summary Judgment") (D.I. 3054) and the responses thereto, after a hearing, and for the reasons set forth in the accompanying Opinion, it is hereby **ORDERED** that:

1. AWI's Motion for Summary Judgment is **GRANTED, IN PART**, to disallow BBU's administrative priority claim with respect to all deliveries made to non-debtor third parties;
2. AWI's Motion for Summary Judgment is **DENIED, IN PART**, with respect to the claim for administrative priority in connection with the goods delivered to Debtor NK Liquidation, Inc. (f/k/a Vida Nell's, Inc.);

3. The parties are directed to confer for the purpose of reaching agreement on the amount of:
 - a. Any remaining BBU Administrative Claims (Claim No. 263); and
 - b. The amount of BBU's general unsecured claims (Claim No. 242);
4. A status (non-evidentiary) hearing concerning BBU's claims will be held on August 2, 2017 at 10:00am in Bankruptcy Courtroom No. 5, 824 Market Street, Fifth Floor, Wilmington, Delaware.
