Upon the Motion for Summary Judgment With Respect to the Executive and
Select Employees Plan Adversary Proceeding and all filings related thereto in the above-
referenced adversary proceeding, (collectively, the “Trustee’s Motion for Summary Judgment,”
ECF Nos. 14128, 14129, 14131),¹ of James W. Giddens (the “Trustee”), as trustee for the
liquidation of Lehman Brothers Inc. (“LBI”) under the Securities Investor Protection Act of

1970, as amended, 15 U.S.C. §§ 78aaa *et seq.* (“SIPA”), seeking entry of an order, pursuant to Federal Rule of Civil Procedure 56, made applicable to this proceeding by Federal Rule of Bankruptcy Procedure 7056, granting summary judgment and reclassifying as subordinated claims of the 349 individuals² (the “Claimants”) listed on Exhibit 1 annexed hereto; and due and proper notice of the Trustee’s Motion for Summary Judgment having been provided to the Claimants, and it appearing that no other or further notice need be provided; and certain of the Claimants having filed a joint opposition to the Trustee’s motion for summary judgment and cross-motion for summary judgment and all filings related thereto in the above-referenced adversary proceeding (collectively, the “Claimants’ Cross-Motion for Summary Judgment,” ECF Nos. 14192, 14193, 14194, 14195, 14196) on March 10, 2017; and the Trustee having filed a reply in support of his motion for summary judgment and opposition to Claimants’ Cross-Motion for Summary Judgment and filings related thereto in the above-referenced adversary proceeding (ECF Nos. 14220, 14221) on April 7, 2017; and certain of the Claimants having filed a reply in support of their cross-motion for summary judgment in the above-referenced adversary proceeding (ECF No. 14253) on May 5, 2017; and the Court having held a hearing on the Trustee’s Motion for Summary Judgment and the Claimants’ Cross-Motion for Summary Judgment on July 12, 2017; and the Court having rendered a Memorandum Decision on (I) the Trustee’s Motion for Summary Judgment with Respect to the Executive and Select Employees Plan Adversary Proceeding and (II) Employees’ Cross-Motion for Summary Judgment (the “Memorandum Decision,” ECF No. 14338) on July 13, 2017; and after due deliberation and sufficient cause appearing therefor, it is hereby

ORDERED that, for the reasons stated in the Memorandum Decision, the Trustee's Motion for Summary Judgment is granted in all respects; and it is further

ORDERED that, for the reasons stated in the Memorandum Decision, the Claimants' Cross-Motion for Summary Judgment is denied in all respects; and it is further

ORDERED that, pursuant to sections 502(b) and 510(a) of title 11 of the United States Code, as made applicable to this proceeding pursuant to sections 78fff(b) and 78fff-1(a) of SIPA, the claims listed on Exhibit 1 annexed hereto are reclassified as contractually subordinated as indicated thereto with prejudice; and it is further

ORDERED that this Court shall retain jurisdiction to hear and determine all matters arising from or related to the implementation and/or interpretation of this Order.
