Additionally, the Owner Lessors reserve all rights to (i) introduce exhibits not listed herein on rebuttal and during cross-examination and/or for the purposes of impeachment; (ii) use documents not listed herein to refresh witnesses' recollections; and (iii) introduce demonstrative exhibits, which could include the exhibits listed herein as well as demonstrative exhibits that incorporate material from the exhibits described herein and from other sources.
