## GENERAL ELECTRIC INTERNATIONAL, INC.'S NOTICE OF WITHDRAWAL OF OBJECTION TO CURE AMOUNTS ASSERTED BY DEBTORS IN THE PLAN SUPPLEMENT AND IN THE CURE NOTICE FILED BY DEBTORS IN CONNECTION WITH THEIR SECOND AMENDED JOINT CHAPTER 11 PLAN OF REORGANIZATION

General Electric International, Inc. respectfully files this Notice of Withdrawal of the Objection to Cure Amounts Asserted by Debtors in the Plan Supplement and in the Cure Notice filed by Debtors in Connection with the Second Amended Joint Chapter 11 Plan of Reorganization (Dkt. #1090), filed by General Electric International, Inc. and Alstom Power, Inc. (collectively, "GE") on November 6, 2017 (the "Objection").

1. In the Objection, GE objected to the cure amounts listed by the Debtors in the Plan Supplement and the Cure Notice regarding the contracts with GE for the reasons listed in the Objection, including because Debtors had not provided GE certain agreements that were the subject of the Plan Supplement and had asserted certain erroneous cure claims.

2. Since the filing of the Objection, Debtors have cured any defaults as referenced in the Objection and Counsel for Debtors and GE have thus resolved the complained of issues, as referenced in email correspondence between the parties' counsel dated November 16, 2017.
