ORDER AUTHORIZING THE DEBTOR TO BORROW \$1,050,000.00

The Rosegarden Health and Rehabilitation Center LLC (“Rosegarden”) and Bridgeport Health Care Center, Inc. (“Bridgeport Health”; collectively Rosegarden and Bridgeport Health are the “Debtors”), filed voluntary chapter 11 bankruptcy petitions on April 18, 2018 (the “Petition Date”). The cases are being jointly administered. The court assumes familiarity with the record of hearings held on April 25, 2018 and April 26, 2018.

The Debtors filed a memorandum of law, ECF No. 50, and clarified during a hearing on April 26, 2018 that the memorandum was in support of their request for court approval of a post-petition, ordinary course loan transaction for the benefit of the Debtors pursuant to 11 U.S.C. § 364(a). But for the court’s concerns about the ordinary course nature of the proposed transactions, and but for objections voiced by creditors, the § 364(a) transactions would not otherwise require court approval. During the hearing the creditor People’s United Bank indicated that the proposed loans were better considered under 11 U.S.C. § 364(b).

The court need not decide the issue regarding the ordinary course nature of the post-petition loan transactions, and instead enters this Order confirming the terms and conditions the parties attending the April 26th hearing agreed upon during the hearing, including the Office of the United States Trustee, the State of Connecticut Department of Social Services, the various unions with members who are employees of the Debtors, and People's United Bank. Accordingly, it is hereby

ORDERED, that, the Debtors are authorized to enter into an unsecured non-priority loan or loans totaling no more than One Million Fifty Thousand (\$1,050,000.00) Dollars from Mr. Chaim Stern, the Chief Financial Officer of Bridgeport Health and the Manager of Rosegarden, for the purpose of making payments of certain necessary expenses to avoid irreparable harm to the Debtors; and it is further

ORDERED, that, the post-petition loan(s) from Mr. Stern to the Debtors is unsecured and without interest, without a term due date at this time; and it is further

ORDERED, that, the parties are deferring consideration of whether the loans from Mr. Stern are entitled to administrative priority pursuant to 11 U.S.C. § 503(b); and it is further

ORDERED, that, the Debtors shall use the borrowed funds to pay the items set forth on the attached EXHIBIT A, which is incorporated herein; and it is further

ORDERED, that, the Debtors shall pay their respective payroll obligations including payroll taxes relating to the Debtors' payroll due to employees on April 20, 2018, the gross payroll amounts due (including payroll taxes and other amounts withheld from employee paychecks for any reason such as employee benefit payments, garnishments, etc.) for the payrolls due to employees on April 27, 2018 and May 4,

2018, the workers compensation insurance premium due on or about April 27, 2018, and the employee health and welfare fund due on or about April 27, 2018 totaling \$24,000.00; and it is further

ORDERED, that, the Debtors shall file a notice on the docket of this case confirming the amount loan receipts within twenty (24) hours of such receipt; and it is further

ORDERED, that, the Debtors shall file a notice on the docket of the case itemizing the amounts paid from the loan proceeds (by category) on or before 6:00 p.m. on Friday, April 27, 2018; and it is further

ORDERED, that, the Debtors shall file a notice on the docket of the case itemizing the amounts paid from the loan proceeds (by category) on or before forty-eight (48) hours after each subsequent payment; and it is further

ORDERED, that, the Debtors are authorized to make such additional payments as are or may become required to maintain the health and safety of the residents of the Debtors' three facilities; provided, however, that the Debtors shall file a notice of any such payments or expenses as soon as practicable.
