**FTI CONSULTING, INC. STAFFING REPORT FOR THE PERIOD

Pursuant to 11 U.S.C. §§ 105(a) and 363(b) and in connection with this Court's *Order Authorizing the Debtors to Employ and Retain FTI Consulting, Inc. to Provide the Debtors a Chief Executive Officer and Chief Restructuring Officer and Certain Additional Personnel, Nunc Pro Tunc to the Petition Date* [D.I. 262] (the "Retention Order"), FTI Consulting, Inc. ("FTI") hereby files its monthly staffing report for the period from March 16, 2018 through May 31, 2018 (the "Staffing Period"), and in support of such report, respectfully represents a follows:

1. On May 29, 2018, FTI was retained by Orion HealthCorp, Inc. and its affiliated debtors and debtors in possession (collectively, the "Debtors") in the above-captioned chapter 11 cases to provide interim management services for the Debtors and Timothy J. Dragelin as Chief Executive Officer and Chief Restructuring Officer. (i) the Debtors, (ii) the United States Trustee and (iii) the Official Committee of Unsecured Creditors.
