## NOTICE OF RELEASE OF FOURTH INTERIM PRIVILEGE LOG

1. On October 30, 2018, Melanie L. Cyganowski, Independent Reviewer, filed a procedure for the release of interim privilege logs in the *Interim Report of Independent Reviewer*, *Melanie L. Cyganowski* (the "Interim Report") [ECF No. 560]. Consistent with that procedure, on December 26, 2018, a fourth interim privilege log (the "Fourth Interim Log") is being provided by e-mail to counsel for the relevant parties and the Court. Prior interim logs have been released on November 13, 2018, November 27, 2018, and December 11, 2018 (collectively, the "Prior Logs"). *See* Notice of First Int. Log, ECF No. 576; Notice of Second Int. Log, ECF No. 597; Notice of Third Int. Log, ECF No. 607.

2. The Fourth Interim Log includes the Independent Reviewer's privilege determinations for 2,001 additional documents, which were reviewed in accordance with the methodology described in the Interim Report.<sup>1</sup> *See* Int. Report 3–6, ECF No. 560.

3. As was the case with the Prior Logs, in order to minimize the likelihood of later revisions, the Fourth Interim Log consists of documents from batches that have been reviewed in full. *See id.* at 3 (describing "batches"); Notice of First Int. Log  $\P$  3, ECF No. 576 (describing purpose of providing only complete batches). Still, the determinations in Fourth Interim Log may be subject to later revision. To the extent that such revisions are necessary, the affected documents will be incorporated in later logs.

4. A cumulative interim log (the "Cumulative Log") is being provided along with the Fourth Interim Log. The Cumulative Log reflects the determinations of all documents reviewed to date, including the determinations from the Prior Logs and the Fourth Interim Log. As stated above, since the release of the Prior Logs, certain documents may have been reviewed again in the context of e-mail threads containing newly reviewed documents and, as a result, a
