1. On February 11, 2019 (the "**Petition Date**"), each of the above-captioned debtors and debtors-in-possession (collectively, the "**Debtors**") commenced with this Court a voluntary case under chapter 11 of the Bankruptcy Code.

2. On February 26, 2019, the Debtors filed a motion for entry of an order, pursuant to sections 105(a), 327, 330 and 363 of the Bankruptcy Code, authorizing the Debtors to employ and compensate professionals utilized in the ordinary course of the Debtors' business (each an "**Ordinary Course Professional**"), *nunc pro tunc* to the Petition Date, subject to certain limits set forth therein [ECF No. 111] (the "**OCP Motion**"). On March 19, 2019, the Court entered an order granting the OCP Motion [ECF No. 206] (the "**OCP Order**").

3. As of the Petition Date, the Debtors asked Orrick to serve as an Ordinary Course Professional to provide legal services to the Debtors relating to various securitization matters expected to arise during the chapter 11 cases.<sup>2</sup>

4. On April 18, 2019, in accordance with the OCP Order, the Debtors filed the *Affidavit and Disclosure Statement of Martin Howard, on Behalf of Orrick, Herrington & Sutcliffe LLP* and Retention Questionnaire [ECF No. 428] (the "**Orrick OCP Affidavit**"). No objections were filed to the Orrick OCP Affidavit.

<sup>&</sup>lt;sup>2</sup> The Debtors have since determined that they will require Orrick to play a larger role in these cases in connection with certain securitization issues. Because of this increased role, Orrick's monthly fees are expected to exceed the Monthly Cap (as defined in the OCP Order) and the \$250,000 cap for the entire period in which these cases will be pending. Thus, on June 6, 2019, pursuant to section 327(e) of the Bankruptcy Code, the Debtors filed an application seeking to employ Orrick as special securitization counsel, *nunc pro tunc* to May 17, 2017 [ECF No. 677] (the "**Orrick 327(e) Application**"). The U.S. Trustee filed a reservation of rights to the Orrick 327(e) Application. No other responses were filed by the June 13, 2019 objection deadline. A hearing on the Orrick 327(e) Application is scheduled for June 20, 2019.

5. Pursuant to paragraph 2(g) of the OCP Order, an Ordinary Course Professional is required to file a fee application when such professional seeks compensation for services rendered and reimbursement for expenses incurred in an amount that exceeds the \$50,000 monthly cap for any month during these chapter 11 cases.

6. Accordingly, pursuant to paragraph 2(g) of the OCP Order, Orrick hereby submits this Second Monthly Fee Statement (the "**Fee Statement**") seeking approval of 100% of its fees incurred as ordinary course securitization counsel to the Debtors for the period May 1, 2019 through May 16, 2019 (the "**Fee Period**") in the amount of \$143,115.76 in fees and \$1,787.72 in expenses, for an aggregate amount of \$144,903.48.<sup>3</sup>
