**THIRD SUPPLEMENTAL NOTICE OF ASSUMPTION
OF EXECUTORY CONTRACTS AND UNEXPIRED LEASES OF
DEBTORS AND REMOVAL OF EXECUTORY CONTRACTS AND UNEXPIRED
LEASES FROM ASSUMED CONTRACTS SCHEDULE (WIND DOWN ESTATES)**

Pursuant to the order of the United States Bankruptcy Court for the Southern District of New York (the “**Bankruptcy Court**”), dated April 23, 2019 (ECF No. 456) (the “**Bidding Procedures Order**”), Ditech Holding Corporation and certain of its subsidiaries and affiliates, as debtors and debtors in possession in the above-captioned chapter 11 cases (collectively, the “**Debtors**”) are seeking to assume and assign certain of their executory contracts and unexpired leases in connection with the sale of substantially all of their assets.

On July 11, 2019, the Debtors filed the *Notice of Assumption or Rejection of Executory Contracts and Unexpired Leases of Debtors (Wind Down Estates)* (ECF No. 837) (the “**Initial**

Notice” and Schedule 1 attached thereto, the “**Initial Schedule**”),² informing parties to certain executory contracts and/or leases that such contracts or leases may be assumed by the Wind Down Estates (each an “**Assumed Contract**” and collectively, the “**Assumed Contracts**”).

On July 26, 2019, the Debtors filed the *Supplemental Notice of Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors and Removal of Executory Contracts and Unexpired Leases from Initial Notice (Wind Down Estates)* (ECF No. 1012) (the “**First Supplemental Notice**” and Schedule 1 attached thereto, the “**First Supplemental Schedule**”), informing parties to certain additional executory contracts and/or unexpired leases listed on the First Supplemental Schedule, which were not previously included on the Initial Schedule, that such contracts or leases may be assumed by the Wind Down Estates (each a “**Assumed Contract**” and collectively, the “**Assumed Contracts**”).

On August 7, 2019, the Debtors filed the *Second Supplemental Notice of Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors and Removal of Executory Contracts and Unexpired Leases from Assumed Contracts Schedule (Wind Down Estates)* (ECF No. 1103) (the “**Second Supplemental Notice**” and Schedule 1 attached thereto, the “**Second Supplemental Schedule**”), informing parties to certain additional executory contracts and/or unexpired leases listed on the Second Supplemental Schedule, which were not previously included on the Initial Schedule or the First Supplemental Schedule, that such contracts or leases may be assumed by the Wind Down Estates (each a “**Assumed Contract**” and collectively, the “**Assumed Contracts**”).

You are receiving this Third Supplemental Notice because you may be (i) a party to an executory contract or unexpired lease not previously identified on the Initial Notice, the First Supplemental Notice, or the Second Supplemental Notice that may be assumed by the Wind Down Estates (each an “Additional Assumed Contract,” and collectively, the “Additional Assumed Contracts”), or (ii) a party to a Assumed Contract that was identified on the Initial Notice, First Supplemental Notice, or Second Supplemental Notice that is being removed from the Initial Schedule, First Supplemental Schedule, or Second Supplemental Schedule (collectively, the “Removed Contracts”).

A schedule of the Additional Assumed Contracts is attached hereto as Schedule 1. A schedule of the Removed Contracts is attached hereto as Schedule 2. Schedule 1, the Initial Schedule, the First Supplemental Schedule, Second Supplemental Schedule, as modified by Schedule 2, are collectively referred to herein as the “**Assumed Contracts Schedule**,” which is attached hereto as Schedule 3.

On July 8, 2019, the Debtors filed the *Notice of Cure Costs and Potential Assumption or Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors* (ECF No. 824) (the “**Initial Cure Notice**”). On July 11, 2019, the Debtors filed the *Supplemental Notice of Cure Costs and Potential Assumption or Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors* (ECF No. 834) (the “**Supplemental Cure Notice**”). On July 26, 2019, the Debtors filed the *Second Supplemental Notice of Cure Costs and Potential Assumption*

or Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors (ECF No. 1013) (the “**Second Supplemental Cure Notice**”). On August 5, 2019, the Debtors filed *Third Supplemental Notice of Cure Costs and Potential Assumption or Assumption and Assignment of Executory Contracts and Unexpired Leases of Debtors* (ECF No. 1087) (together with the Initial Cure Notice, the Supplemental Cure Notice, and the Second Supplemental Cure Notice, the “**Cure Notices**”). The Cure Notices provide procedures non-Debtor parties must follow regarding any objections to the Debtors’ proposed “Cure Amounts” set out in Exhibit A to the applicable Cure Notice as stated as owed under each Assumed Contract and Additional Assumed Contract (the “**Cure Costs**”) should their contracts be assumed by the Wind Down Estates. This Second Supplemental Notice is in addition to the Cure Notices.

To the extent that a non-Debtor party to an Additional Assumed Contract that was not included in the Initial Notice, First Supplemental Notice, or Second Supplemental Notice objects to the assumption of such party’s Additional Assumed Contract, such non-Debtor party must file and serve an Adequate Assurance Objection by September 27, 2019 at 4:00 p.m. (prevailing Eastern Time). Non-Debtor parties to an Assumed Contract identified in the Initial Notice, First Supplemental Notice, or Second Supplemental Notice must have filed and served an Adequate Assurance Objection by the deadline set forth in the Initial Notice, First Supplemental Notice, or Second Supplemental Notice, as applicable. All Adequate Assurance Objections must be filed and served in accordance with the Bidding Procedures Order, copies of which are available for download at dm.epiq11.com/case/Ditech/info.

If no Adequate Assurance Objection is timely filed and served with respect to an Assumed Contract, the Debtors will be deemed to have provided adequate assurance of future performance for such Assumed Contract in accordance with section 365(f)(2)(B) of the Bankruptcy Code, and the non-Debtor party to the Assumed Contract shall be deemed to have consented to the assumption of the Assumed Contract by the Wind Down Estates and shall be forever barred from asserting any objection with regard to such assumption.

The Debtors will seek to approve the Sale Transaction at the Confirmation Hearing scheduled to begin on September 25, 2019 at 11:00 a.m. (prevailing Eastern Time) before the Honorable James L. Garrity, Jr. in the United States Bankruptcy Court for the Southern District of New York, One Bowling Green, Courtroom 601, New York, New York 10004 in accordance with the Bidding Procedures Order. Adequate Assurance Objections, if any, will be heard at a later hearing date to be determined by the Debtors.

The inclusion of any contract or lease on the Assumed Contracts Schedule, including **Schedule 1** hereto, shall not constitute or be deemed a determination or admission by the Debtors

that such contract or other document is, in fact, an executory contract or unexpired lease within the meaning of the Bankruptcy Code (all rights with respect thereto being expressly reserved).
