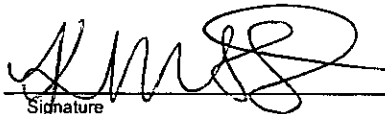

Service Agreement

KLDisc Discovery Ontrack, LLC on behalf of itself and its affiliates ("Vendor") and Client agree that all services performed under this SOW will be governed by the following terms and conditions:

2. The Services

2.1 KLDisc Discovery shall make the Services available to Client and its Users pursuant to the terms of this Agreement. Access to and use of the Services is granted solely to the Client stated in the Agreement and shall not be shared with any third parties other than those designated by Client and approved by KLDisc Discovery.

4. Fees and Payments

4.1 The Fees shall be as set forth in the ESI Services Pricing Schedule above. The Fees do not include applicable service taxes for which Client shall be responsible. The terms Firm, Client, and Firm's Client in this section shall be directly referenced with the definition in section 1.1.

4.2 Client agrees to pay KLDisc Discovery all sums for provision of the Services together with any approved expenses. KLDisc Discovery will invoice for work completed as follows: (i) excluding managed review, all fees invoiced on a monthly basis in arrears for the duration of the Project; and/or (ii) managed review work shall be invoiced twice a month in arrears for the duration of the Project. All invoices are payable within 30 days of date of invoice. Fees are non-refundable and based on Services purchased and not actual usage (except for Fees based on volume in the case of coverage Fees). Client expressly agrees that payment to KLDisc Discovery for Services rendered is not contingent on the outcome of the Project set out in the SOW or on Firm's receipt of payment from Firm's Client.

4.3 Client understands that, in the event of non-payment of invoices, KLDisc Discovery: (i) reserves the right to suspend performance of, and/or terminate, its Services, including the availability of its software and platforms at any time; and/or (ii) charge interest on late payment in the amount of 1 1/2% per month, or the maximum percentage allowable under state law. The Client shall pay all costs of collection of unpaid debts, including, without limitation, reasonable legal fees.

4.4 Where KLDisc Discovery is engaged by a Firm for Services ultimately rendered for Firm's Client and Firm's Client is not a signatory to this Agreement, Firm represents that it has obtained the authority from Client to bind Client under and according to the terms of this Agreement, including the terms to honor all invoices presented by KLDisc Discovery for work performed under this Agreement.

4.5 Where KLDisc Discovery is engaged by a Client solely, Client shall pay KLDisc Discovery within 30 days from the date of invoice (the "Due Date").

4.6 Where KLDisc Discovery is engaged by a Firm solely, Firm shall pay KLDisc Discovery within 30 days from the date of invoice (the "Due Date").

4.7 Client will notify KLDisc Discovery in writing of any disputed fees within ten (10) days of invoice date, otherwise KLDisc Discovery's invoices shall be deemed payable in full. Upon notice of such disputed fees, the Parties reserve a thirty (30) day period for validation of the disputed fee or cure of any claimed and validated defect. Thereafter, the initial invoice or an updated invoice shall be issued to Client.

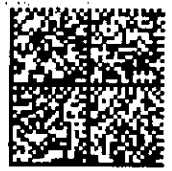
