**DECLARATION OF JAMES SKLAR IN SUPPORT OF
DEBTORS' ENTRY INTO EXCLUSIVE AUCTION AND SALES
AGREEMENT BETWEEN THE DEBTORS AND HERITAGE
GLOBAL PARTNERS, INC., FEDERAL MACHINERY & EQUIPMENT
COMPANY, CAPITAL RECOVERY GROUP, LLC AND PPL GROUP LLC**

I, James Sklar, being duly sworn according to law, hereby declare as follows:

1. My name is James Sklar. I am over the age of 21 and am competent in all respects to make this Declaration. I am the General Counsel at Heritage Global Partners, Inc. (“HGP”). As such, I have direct knowledge of the facts contained in this declaration (the “**Declaration**”). Accordingly, I am authorized and competent in all respects to make this Declaration on behalf of HGP in support of the Exclusive Auction and Sales Agreement (the “**Auction and Sales Agreement**”) between Insys Therapeutics, Inc. and its affiliated debtors in the above-captioned chapter 11 cases (the “**Chapter 11 Cases**”), as debtors and debtors in possession (collectively, the “**Debtors**”) and HGP, Federal Machinery & Equipment Company (“**Federal**”), Capital Recovery Group, LLC (“**CRG**”), and PPL Group LLC (“**PPL**” and together with HGP, Federal, and CRG, the “**Auctioneer**”) for the Debtors to retain HGP in connection with the *Motion of Debtors*

Pursuant to 11 U.S.C. §§ 105(a), 363, and 554 and Fed. R. Bank. P. 2002 for Approval of (I) Procedures for the Expedited Sale, Transfer or Abandonment of De Minimis Assets, and (II) Entry into an Exclusive Auction and Sales Agreement [Docket No. 985] (the “Motion”). Except as otherwise noticed, I have personal knowledge of all of the information set forth herein.

2. HGP is in the business of conducting auctions and liquidation sales of certain assets, with a primary focus on assets relevant in industrial contexts. HGP is well-established and maintains an excellent reputation in its industry. Moreover, HGP has significant experience conducting auctions and sales substantially identical to the process proposed in the Auction and Sales Agreement for numerous clients. For these reasons, I believe that HGP is well-qualified to act as the Debtors’ auctioneer in these Chapter 11 Cases and to conduct the auction and sale process proposed in the Auction and Sales Agreement.

3. To the best of my knowledge, information, and belief, based on reasonable inquiry, (i) neither I, HGP, nor the other officers and directors of HGP that are anticipated to provide services to the Debtors in these Chapter 11 Cases, nor the employees of HGP who may provide such services hold or represent any interest adverse to any of the Debtors with respect to the matters for which HGP is to be retained. Further, HGP and its officers and directors have no relationship to the Debtors, any of the Debtors’ significant creditors, other known parties in interest in these Chapter 11 Cases, the Office of the United States Trustee for Region 3, or the attorneys or professions that are known to be assisting the Debtors in these Chapter 11 Cases, except as is described below.

4. From time to time, HGP and its affiliates have provided services, may currently provide services, and likely will continue to provide services to certain creditors of the Debtors, other parties in interest in these Chapter 11 Cases, and various other parties potentially adverse to

the Debtors in matters unrelated to these Chapter 11 Cases. As described in more detail below, however, HGP has undertaken an internal search to determine whether it is or has been employed by or had other relationships with any entities that were listed on schedules provided to HGP by the Debtors in connection with these Chapter 11 Cases. As noted herein, certain of these creditors, interested parties, attorneys, or accountants have or may have provided goods or services to, currently provide or may currently provide goods or services to, and may in the future provide goods and services to HGP, its affiliates, or its officers and directors in matters unrelated to these Chapter 11 Cases.

5. To check and disclose possible relationships with parties interested in these Chapter 11 Cases, HGP performed reasonable due diligence to determine whether it had any relationships with the entities that were listed on schedules provided to HGP by the Debtors in these Chapter 11 Cases. From its search, HGP has determined that no relationships or connections are required to be disclosed in connection with the Auction and Sales Agreement.

6. Except as may be disclosed herein, to the best of my knowledge, HGP and its officers and directors do not hold or represent any interest adverse to the Debtors, their creditors, or their estates. Accordingly, I believe that HGP and its officers and directors are “disinterested persons” as that term is defined in section 101(14) of the Bankruptcy Code, as modified by section 1107(b) of the Bankruptcy Code. HGP holds no prepetition claims against the Debtors.

7. HGP may have sold certain goods in various auctions it has conducted to entities on the conflict search list and has provided asset disposition services to certain entities on the conflict search list, all in matters unrelated to the Chapter 11 cases. HGP does not believe either of these potential connections impair its disinterestedness.


8. If HGP discovers any information that is contrary to or pertinent to the statements made herein, I will promptly disclose such information to the Court by filing and serving a supplement to this Declaration. Additionally, HGP will continue to review information related to potential interested parties in these Chapter 11 Cases as such information becomes available. To the extent that HGP discovers any connection with any interested party or enters any new relationship with any interested party, HGP will promptly supplement its disclosure to the Court.

9. Subject to this Court's approval and pursuant to the terms herein and in the Auction and Sales Agreement, the Debtors and HGP have agreed that Auctioneer, including HGP, will provide the services described in the Auction and Sales Agreement and will conduct the auction and sale of the assets described in Exhibit A to the Auction and Sales Agreement (the "**De Minimis Assets**") on behalf of the Debtors, their creditors, and their estates pursuant to the terms set forth therein. The Debtors and Auctioneer have further agreed that the proceeds of the proposed sale of the De Minimis Assets will be remitted to the Debtors, provided that Auctioneer will be compensated pursuant to the terms set forth in the Auction and Sales Agreement, summarized as follows:

- a. Auctioneer guarantees that the Debtors will receive a minimum return of \$150,000 as a result of the Auction of the De Minimis Assets. Auctioneer will then retain, as expense reimbursement and partial compensation, the next \$30,000 in Auction sale proceeds (meaning those proceeds between \$150,000 and \$180,000). All proceeds in excess of \$180,000 shall be remitted to Debtors. Separate from the Auction proceeds, Auctioneer shall charge each De Minimis Asset purchaser an 18% Buyer's Premium and retain all sums collected as such Buyer's Premium as its compensation.

10. HGP has not received any retainer from the Debtors or any other entity in connection with these Chapter 11 Cases. Other than as set forth herein, there is no proposed arrangement to compensate HGP. HGP has not shared or agreed to share (a) any compensation it may receive in connection with these Chapter 11 Cases with any other party or person, other than with the employees of HGP and affiliated entities, or (b) any compensation another person or party has received or may receive.
