NOTICE OF WITHDRAWAL OF PROOF OF CLAIM NO. 28

Claims at Issue: 13, 28

Genisys Corporation states as follows:

1. On March 16, 2018, the above-captioned debtors ("Debtors") filed voluntary petitions under Chapter 11 of the Bankruptcy Code. On March 22, 2018, the Debtors' bankruptcy cases became jointly administrated under Case No. 18-71748.

2. There are two proofs of claim in favor of Genisys Corporation against the Debtors. These claims are listed in the claims registry of the Debtors as Claim Nos. 13 and 28. Claim No. 28 is a duplicate of Claim No. 13. Genisys Corporation did not cause this duplication, and the fact that duplicate claims currently exist in the claims registry is inadvertent.

3. Pursuant to Bankruptcy Rule 3006, Cypress – Genisys Corporation hereby withdraws Claim No. 28. Claim No. 13 will remain on the claims registry, subject to the understanding that Howard M.
