PLAINTIFF'S *EX PARTE* VERIFIED MOTION FOR ENTRY OF CLERK'S DEFAULT <u>AGAINST DEFENDANT RONALD KANS D/B/A HYPER LANDSCAPING & DESIGN</u>

Plaintiff 1 Global Capital LLC, pursuant to Rule 55 of the Federal Rules of Civil Procedure,

made applicable to this proceeding by Rule 7055 of the Federal Rules of Bankruptcy Procedure,

and Local Rule 7055-1, moves for entry of a clerk's default against Defendant, Ronald Kans d/b/a

Hyper Landscaping & Design and Ronald Kans ("Defendant"), and in support thereof states:

Background

1. On September 27, 2019, Plaintiff filed a Complaint (the "Complaint) against Defendant.

2. On September 29, 2019: (a) the Clerk of the Court issued a *Summons and Notice of Pretrial/Trial in an Adversary Proceeding* informing Defendant that he was required to file a response or answer to the Complaint within 30 days after issuance of the Summons- by October 29, 2019 (ECF No. 2) (the "Summons"); and (b) the Court entered its *Order Setting Filing and Disclosure Requirements for Pretrial and Trial* (the "Pretrial Order").

3. On October 3, 2019, Plaintiff served a copy of the: (a) Complaint, (b) Summons; and (c) Pretrial Order on the Defendant.

4. As of the filing of this Motion, no response has been filed to the Complaint.

5. Accordingly, the Plaintiff seeks entry of a Clerk's Default against Defendant for failure to timely respond to the Complaint.

WHEREFORE, Plaintiff requests that the Clerk of the Court enter a Default against Defendant, Ronald Kans d/b/a Hyper Landscaping & Design, for failure to timely respond to the Complaint.
