5. By September 28, 2020, Plaintiff's counsel shall file a Status Report providing the status of each of the Collection Proceedings. For all proceedings not resolved by settlement, dismissal or judgment, the Status Report shall indicate whether the proceeding is ready for trial and, if not, the date requested by the Plaintiff for a final pretrial conference after completion of discovery.

6. The Clerk is directed to docket a copy of this Order in all of the Collection Proceedings.

7. Plaintiff's Counsel shall serve a copy of this Order on all defendants in the Collection Proceedings and file a Certificate of Service in each of the Collection Proceedings.
