DEFAULT FINAL JUDGMENT AGAINST LEONARD POWELL AND SUE POWELL

THIS CAUSE, having come before the Court on Plaintiff's Ex Parte Motion For Entry of Default Final Judgment Against Leonard Powell and Sue Powell (collectively, the "Defendants") pursuant to Fed.R.Civ.P. 55, made applicable by Fed.R.Bank.P. 7055, following entry of a Clerk's Default against Defendants in this adversary proceeding, and in conformity with this Court's Order Granting Plaintiff's Ex Parte Motion for Default Final Judgment entered simultaneously herewith, and finding that the Court has jurisdiction over the parties and the subject matter, and pursuant to Fed.R.Bankr.P. 7058, the Court hereby FINDS AND

DETERMINES THAT:

- This Court has jurisdiction over this action pursuant to 28 U.S.C. §§ 157 and A. 1334(b) and Fed.R.Bankr.P. 7001.
 - В. Venue is proper herein pursuant to 28 U.S.C. § 1409(a).
- C. The findings and conclusions set forth herein constitute the Court's findings of fact and conclusions of law pursuant to Bankruptcy Rule 7052.
- D. To the extent any of the following findings of fact constitute conclusions of law, they are adopted as such. To the extent any of the following conclusions of law constitute findings of fact, they are adopted as such.
- E. Proper, timely, adequate and sufficient service of the Complaint, Summons, and Pretrial Order were provided to Defendants.
- F. Proper, timely, adequate and sufficient service of the Plaintiff's Motion for Clerk's Default were provided to Defendants.
 - G. Defendants had adequate time to respond to the Complaint and failed to do so.
 - H. The factual allegations asserted in the Complaint with respect to Defendants are

deemed admitted and are incorporated by reference.

I. A certified copy of this Order may be filed with the appropriate clerk and/or recorded with the county recorder to effectuate the relief provided herein.

Accordingly, it is **HEREBY ADJUDGED THAT:**

- 1. Final Judgment is entered in favor of 1 Global Capital LLC as to Count 1 of the Complaint, and against Defendant, Leonard Powell, for the total sum of \$65,464.32, which amount shall bear interest from this date forward at the prevailing legal rate of interest, all for which let execution issue forthwith.
- 2. Final Judgment is entered in favor of 1 Global Capital LLC as to Count 2 of the Complaint, and against Defendant, Sue Powell, for the total sum of \$65,464.32, which amount shall bear interest from this date forward at the prevailing legal rate of interest, all for which let execution issue forthwith.
- 3. The Plaintiff's address is: 500 West Cypress Creek Road, Suite 400, Fort Lauderdale, FL 33309.
- 4. The last known address of Leonard Powell is: 1395 Wade Hampton Road, Dublin, GA 31021.
- 5. The last known address of Sue Powell is: 1236 Hwy 441 Bypass, Dublin, GA 31021-1693.
- 6. Plaintiff is the prevailing party in this matter and is awarded its costs. Plaintiff shall submit to the Clerk of Court a proposed Local Form "Bill of Costs" and file a certificate of service in accordance with Local Rule 2002-1(F).

7. Pursuant to *Fed. R. Bankr. P.* 7069 and *Fla. R. Civ. P.* 1.560, Defendants shall complete under oath *Fla. R. Civ. P.* Form 1.977 (Fact Information Sheet), including all required attachments, within 45 days of the order or such other reasonable time as determined by the Court. Failure to obey the order may be considered contempt of court.

8. The Court reserves jurisdiction to enter any further orders and decrees as are proper; modify, supplement, amend, enforce and implement the terms and provisions of this Final Judgment; or take any other actions that may be necessary in connection with this matter, including but not limited to, the issuance of writs of execution.
