**NOTICE OF POSSIBLE ASSUMPTION AND ASSIGNMENT
AND CURE AMOUNTS WITH RESPECT TO EXECUTORY
CONTRACTS AND UNEXPIRED LEASES OF THE DEBTOR**

The above-captioned debtor and debtor-in-possession (the “**Debtor**”) filed a voluntary petition for relief under chapter 11 of title 11 of the United States Code, 11 U.S.C. §§ 101 *et seq.* (the “**Bankruptcy Code**”), on January 27, 2020, in the United States Bankruptcy Court for the District of Delaware (the “**Bankruptcy Court**”). The Debtor is seeking to assume and assign certain of its executory contracts and unexpired leases in connection with the sale (the “**Sale**”) of all or substantially all of its assets in one or more lots (the “**Assets**”), free and clear of all liens, claims, encumbrances, and other interests. The Debtor is seeking Court approval of such Sale and assumptions and assignments pursuant to a motion, dated April 1, 2020 at Docket No. 278 (the “**Motion**”).

By order, dated April 29, 2020 [Docket No. 377] (the “**Bidding Procedures Order**”),² the Bankruptcy Court approved certain “**Bidding Procedures**” that govern the sale of the Debtor’s Assets to the highest or best bidders. Copies of the Motion and the Bidding Procedures Order are available for download at <https://dm.epiq11.com/case/southland/dockets> (the “**Case Website**”) or by calling the Debtor’s claims and noticing agent, EPIQ, at 866-977-0768.

You are receiving this Notice because you may be a party to an unexpired lease or an executory contract that is potentially to be assumed and assigned (collectively, the “*Proposed Assumed Contracts*”), in connection with such Sale. A list of the Proposed Assumed Contracts is attached hereto as Exhibit A.

The Debtor has investigated the current amounts owing under each Proposed Assumed Contract, and has listed beside each contract on Exhibit “A” attached hereto the amount (the “**Cure Amounts**”) proposed to be paid upon any assumption and assignment of the Proposed Assumed Contracts. Payment of the Cure Amount will be in full satisfaction and settlement of all amounts outstanding and to cure all defaults under the Proposed Assumed Contracts.

Any objection to the (i) assumption, assignment or Cure Amount for the Proposed Assumed Contracts or (ii) provision of adequate assurance of future performance pertaining to the Stalking Horse Purchaser(s) (excluding, however, the provision of adequate assurance of future performance pertaining to other Successful Bidder(s)), which are subject to the deadline in the following paragraph), must be filed with the Bankruptcy Court and served on the Objection Notice Parties (as defined below) (a “*Contract Objection*”). Any Contract Objection shall: (i) be in writing; (ii) comply with the Bankruptcy Rules and the Local Rules; (iii) be filed with the Clerk of the Court, 824 N. Market Street, 3rd Floor, Wilmington, Delaware 19801, together with proof of service, on or before 11:30 a.m. (ET) on May 28, 2020 (the “*Contract Objection Deadline*”); (iv) be served by mail or email, so as to be actually received on or before the Contract Objection Deadline, upon the Objection Notice Parties; and (v) state with specificity the grounds for such Contract Objection, including, without limitation, the fully liquidated cure amount and the legal and factual bases for any unliquidated cure amount that the Counterparty believes is required to be paid under section 365(b)(1)(A) and (B) of the Bankruptcy Code for the Proposed Assumed Contract, along with the specific nature and dates of any alleged defaults, the pecuniary losses, if any, resulting therefrom, and the conditions giving rise thereto. Contract Objections must include all objections to assumption and assignment of the Proposed Assumed Contracts, including any objections concerning adequate assurance of future performance by any Stalking Horse Purchaser.

No later than one business day after the date of the Auction, the Debtor will cause to be served by overnight mail upon each affected Counterparty and its counsel (if known): (i) a Notice of Successful Bidder and (ii) the Successful Bidder’s (which may be the Stalking Horse Bidder) Adequate Assurance Information (to the extent not previously provided). The Counterparties will file any Contract Objections *solely* on the basis of adequate assurance of future performance by a Successful Bidder other than the Stalking Horse Purchaser as soon as practical and may also raise such objections at the Sale Hearing.

Subject to the terms of the Bidding Procedures Order, an auction (the “**Auction**”) for the Assets, including the Contracts, will be conducted on May 22, 2020 or such other date as the Debtor may notify Qualified Bidders, at a time and location, or by telephone, as determined by the Debtor.

No later than one business day after the date of the Auction, the Debtor will file with the Court a notice identifying the Successful Bidder (a “*Notice of Successful Bidder*”), which will set forth, among other things, (i) the Successful Bidder and Back-Up Bidder (if any), (ii) the Designated Contracts (as defined below), (iii) the proposed assignee(s) of such Designated Contracts, and (iv) a certification by the Debtor that the Debtor has provided, or will provide, in coordination with the proposed assignee, the Successful Bidder’s Adequate Assurance Information to each affected Counterparty on a confidential basis.

No later than one business day after the date of the Auction, the Debtor will cause to be served by overnight mail upon each affected Counterparty and its counsel (if known): (i) the Notice of Successful Bidder and (ii) the Successful Bidder’s (which may be the Stalking Horse Bidder) Adequate Assurance Information (to the extent not previously provided). **The Counterparties will file any Contract Objections solely on the basis of adequate assurance of future performance by a Successful Bidder other than the Stalking Horse Purchaser as soon as practical and may also raise such objections at the Sale Hearing.**

The Debtor will seek to assume and assign the Proposed Assumed Contracts that have been selected by a Successful Bidder, which may be the Stalking Horse Bidder, (collectively, the “**Designated Contracts**”) at a hearing before the Honorable Judge Karen B. Owens, in the United States Bankruptcy Court for the District of Delaware, 824 North Market Street, 6th Floor, Courtroom 3, Wilmington, Delaware 19801 (a “**Sale Hearing**”) on May 28, 2020 at 1:30 p.m. (ET). The Sale Hearing may be adjourned by the Debtor from time to time without further notice to creditors or other parties in interest other than by announcement of the adjournment in open court or by filing a hearing agenda or notice on the docket of the Debtor’s chapter 11 case.

If additional executory contracts or unexpired leases of the Debtor are determined to be Proposed Assumed Contracts, as soon as practicable thereafter and in no event later than eight days before the date of the Sale Hearing, the Debtor will file with the Court and serve, by overnight delivery, on the Counterparties an Assumption Notice, and Counterparties to the Proposed Assumed Contracts on such Assumption Notice will file and serve any Contract Objections by the earlier of: (i) fourteen days after service of the Assumption Notice on such Counterparties and (ii) two hours prior to the commencement of the Sale Hearing.

If no Contract Objection is timely received with respect to a Designated Contract: (i) the counterparty to such Designated Contract will be deemed to have consented to the assumption by the Debtor and assignment to any Stalking Purchaser or Successful Bidder, as applicable, of the Designated Contract, and be forever barred from asserting any objection with regard to such assumption and assignment (including, without limitation,

with respect to adequate assurance of future performance by any Stalking Purchaser or Successful Bidder, as applicable); (ii) any and all defaults under the Designated Contract and any and all pecuniary losses related thereto will be deemed cured and compensated pursuant to section 365(b)(1)(A) and (B) of the Bankruptcy Code; and (iii) the Cure Amount for such Designated Contract will be controlling, notwithstanding anything to the contrary in such Designated Contract, or any other related document, and the Counterparty will be deemed to have consented to the Cure Amount and will be forever barred from asserting any other claims related to such Designated Contract against the Debtor and its estate or any Stalking Purchaser or Successful Bidder, as applicable, or the property of any of them, that existed prior to the entry of the Sale Order.

To the extent that the parties are unable to consensually resolve any Contract Objection prior to the commencement of the Sale Hearing, including, without limitation, any dispute with respect to the cure amount required to be paid to the applicable Counterparty under section 365(b)(1)(A) and (B) of the Bankruptcy Code (any such dispute, a “*Cure Dispute*”), such Contract Objection will be adjudicated at the Sale Hearing or at such other date and time as may be determined by the Debtor or fixed by the Court; *provided, however*, that if the Contract Objection relates solely to a Cure Dispute, the Designated Contract may be assumed by the Debtor and assigned to any Stalking Purchaser or Successful Bidder, as applicable, *provided that* the cure amount that the Counterparty asserts is required to be paid under section 365(b)(1)(A) and (B) of the Bankruptcy Code (or such lower amount as agreed to by the Counterparty) is deposited in a segregated account by the Debtor or any Stalking Purchaser or Successful Bidder, as applicable, pending the Court’s adjudication of the Cure Dispute or the parties’ consensual resolution of the Cure Dispute.

If, after the Sale Hearing or the entry of the Sale Order, additional executory contracts or unexpired leases of the Debtor are determined to be Designated Contracts, the Debtor will file with the Court and serve, by overnight delivery, on the Counterparties an Assumption Notice, and such Counterparties will file any Contract Objections not later than fourteen (14) days after the date of such service. If no Contract Objection is timely received, the Debtor will be authorized to assume and assign such Designated Contracts to any Stalking Purchaser or Successful Bidder, as applicable, without further notice to creditors or other parties in interest and without the need for further order of the Court, and such assumption and assignment shall be subject to the terms of the Sale Order.

Some of the instruments on Exhibit “A” may be real property interests and not executory contracts pursuant to applicable bankruptcy and nonbankruptcy law. Notwithstanding this notice, the Debtor reserves all rights regarding the particular legal characteristics of any instrument, including, without limitation, whether any such instrument is executory or nonexecutory, constitutes a contract, real property or other interest, or whether and to what extent it is governed by section 365 of the Bankruptcy Code.
