PLEASE TAKE FURTHER NOTICE that neither this Notice of Appearance and Request for Service of Notice and Papers, nor any later appearance, pleading, or claim or suit is intended nor shall be deemed (a) a consent by Chorus Aviation (i) to the jurisdiction of this Court or any other court with respect to proceedings, if any, commenced in any case against or otherwise involving Chorus Aviation; and (ii) that these Chapter 11 Cases constitute the “primary insolvency jurisdiction” (as defined in the Protocol to the Convention on International Interests in Mobile Equipment on Matters Specific to Aircraft Equipment) of any or all of the debtors in these Chapter 11 Cases; or (b) to waive Chorus Aviation’s (i) right to have final orders in non-core matters, or in any core matter in which this court lacks constitutional authority to enter a final order, entered only after *de novo* review by a District Judge for the United States District

Court for the Southern District of New York (the “District Court”); (ii) right to trial by jury in any proceeding related to these Chapter 11 Cases or any case, controversy or proceeding related hereto; (iii) right to have the reference withdrawn by the District Court in any matter subject to mandatory or discretionary withdrawal; (iv) right to object to the jurisdiction of the Bankruptcy Court or any other court for any purpose; (v) right to an election of remedy; or (vi) other rights, claims, actions, defenses, setoffs or recoupments to which it is or may be entitled under agreements, at law or in equity, all of which rights, claims, actions, defenses, setoffs and recoupments expressly are hereby reserved.
