2. I am fully familiar with the facts hereinafter stated, and am authorized to make this supplemental declaration (the "Supplemental Declaration") on behalf of Arent Fox. The information contained in this Supplemental Declaration is based on my own personal knowledge, discussions with my partners, associates, and staff at Arent Fox, or is derived from my review of the file in these cases.<sup>1</sup>

2014(a), regarding Arent Fox's representation of the Official Committee of Unsecured Creditors (the "Committee") in the chapter 11 case of Walker County Hospital Corporation, d/b/a Huntsville Memorial Hospital (the "Debtor").

4. This Supplemental Declaration is submitted to supplement the Declaration of George P. Angelich (the "Initial Declaration") submitted on December 27, 2019, in support of the Application of Committee to employ and retain Arent Fox as counsel to the Committee *nunc pro tunc* to November 27, 2019 [Docket. No. 93] (the "Retention Application").

5. On December 11, 2019, the Debtor filed its Schedules of Assets and Liabilities (the "Schedules") [Docket No. 162] and Statement of Financial Affairs (the "SOFA") [Docket No. 163].

6. In connection with this Supplemental Declaration, Arent Fox reviewed and analyzed the Debtor's Schedules and SOFA and conducted a conflicts and connections search of all parties listed therein. Additionally, Arent Fox reviewed the case docket and conducted a conflicts and connections search of those parties who have requested service of all motions and pleadings pursuant to Bankruptcy Rule 2002, their counsel and other parties-in-interest in the case. Arent Fox's search included more than 1,000 parties-in-interest.

7. Arent Fox files this Supplemental Declaration to identify connections to parties-in-interest appearing in this case as set forth on **Exhibit 1** annexed hereto. As disclosed in **Exhibit 2**, Arent Fox has in the past represented, currently represents, and may in the future represent parties-in-interest in the Debtor's chapter 11 case, in matters unrelated to this case.

8. Arent Fox will continue to research connections with respect to its representation of the Committee in this case, and reserves the right to supplement its disclosures as necessary in order to disclose any conflicts or connections as appropriate.
