**OMNIBUS ORDER RESETTING PRETRIAL CONFERENCES**

As announced at the pretrial conference held for the adversary proceedings on October 8, 2020 (the “Collection Proceedings”), it is –

**ORDERED** as follows:

1. All of the Collection Proceedings listed on the attached list (the “Collection Proceedings”) and previously set for pretrial conferences are reset.
2. The Court will conduct the pretrial conference for the Collection Proceedings on February 11, 2021 at 2:00 p.m. The hearing will be a telephonic hearing and all participants must appear through CourtSolutions. To participate through CourtSolutions, you must make a reservation in advance no later than 3:00 p.m., one business day before the date of the hearing. Reservations should be arranged online at <http://www.Court-Solutions.com>. If a party is unable to register online, a reservation may also be made by telephone at (917) 746-7476.

3. The trial date in the Collection Proceedings will be set at the pretrial conference.
4. The parties shall comply with the requirements set forth in the initial Order Setting Filing and Disclosure Requirements for Pretrial. The time deadlines in the Order, as they relate to the Pretrial Conference, shall refer to the rescheduled date.
5. By February 1, 2021, Plaintiff's counsel shall file a Status Report providing the status of each of the Collection Proceedings. For all proceedings not resolved by settlement, dismissal or judgment, the Status Report shall indicate whether the proceeding is ready for trial and, if not, the date requested by the Plaintiff for a final pretrial conference after completion of discovery.
6. The Clerk is directed to docket a copy of this Order in all of the Collection Proceedings.
7. Plaintiff's Counsel shall serve a copy of this Order on all defendants in the Collection Proceedings and file a Certificate of Service in each of the Collection Proceedings.
