FINAL ORDER GRANTING SAEXPLORATION, INC.'S EMERGENCY MOTION FOR AUTHORITY TO TRANSFER FUNDS TO SAEXPLORATION HOLDINGS, INC. AND SAEXPLORATION SEISMIC SERVICES (US), LLC

[Related to Docket Nos. 204 and 233]

SAExploration, Inc.'s Emergency Motion for Authority to Transfer Funds to SAExploration Holdings, Inc. and SAExploration Seismic Services (US), LLC (the "Motion") originally came on for consideration on October 15, 2020 (the "Initial Hearing").² After the Initial Hearing, the Court entered the Order (I) Granting in Part SAExploration, Inc.'s Emergency Motion for Authority to Transfer Funds to SAExploration Holdings, Inc. and SAExploration Seismic Services (US), LLC; and (II) Setting Final Hearing on the Motion [Docket No. 233], which, among other things, set the Motion for a final hearing on November 3, 2020 (the "Final Hearing").

This Court, having reviewed the Motion and the evidence admitted at the Initial Hearing and the Final Hearing, if any, and having determined that notice of the Motion as set forth therein is sufficient under the circumstances, finds that the relief requested in the Motion is in the

- SAExploration, Inc. is authorized to deposit \$1,000,000.00 from the Corporate
 Operating Account into the Holdings Account.
- 2. SAExploration, Inc. is authorized to deposit an additional \$250,000.00 from the Corporate Operating Account into the Lower 48 Operating Account.
- 3. The Debtors are authorized to take any and all further action as may be necessary to effectuate the terms and provisions of this Order.
