NOTICE OF (I) ERRATA REGARDING CLASS 2 (OTHER SECURED CLAIM) AND CLASS 4 (GENERAL UNSECURED CLAIM) BALLOTS FOR VOTING ON DEBTORS' SECOND AMENDED JOINT PLAN OF LIQUIDATION [DOCKET NO. 1405] AND (II) EXTENSION OF VOTING DEADLINE FOR CERTAIN HOLDERS OF CLASS 2 AND 4 CLAIMS

1. On October 9, 2020, the above-captioned debtors and debtors in possession (the "Debtors") filed the *Debtors' Second Amended Joint Plan of Liquidation* [Dkt. 1405] ("Plan") and the related disclosure statement [Dkt. 1406] (the "Disclosure Statement").²

2. As set forth in the Plan and the Disclosure Statement, all Holders of Claims and Interests, even those Holders of Class 2 and 4 Claims that vote to ACCEPT the Plan, are entitled to opt-out of the Third-Party Release contained in Article VIII.D of the Plan.

3. Solicitation of votes to accept the Plan was commenced on or about October 13, 2020. After the Plan, the Disclosure Statement and other solicitation materials, including the Ballots, were distributed to Holders of Claims that may be entitled to vote on the Plan, the Debtors became aware of an error in the Ballots distributed to the Holders of Class 2 Claims (Other Secured Claims) and Class 4 Claims (General Unsecured Claims). Specifically, although the Plan, the Disclosure Statement and the Ballots themselves state in several places that Holders of Class 2 and 4 Claims that vote to ACCEPT the Plan, are entitled to opt-out of the Third-Party Release contained in Article VIII.D of the Plan, the Ballots also imply in one instance that the ability to opt-out of the Third-Party Release is not available if the Claimant has voted their Claim to ACCEPT the Plan. **This is incorrect. Holders of Class 2 and 4 Claims that vote to ACCEPT the Plan, are entitled to opt-out of the Third-Party Release contained in Article VIII.D of the Plan.**

4. Please contact the Balloting Agent, Epiq Corporate Restructuring, LLC, as described in Paragraph 5 below by **Tuesday, November 3, at 4:00 p.m. (ET)**, if you believe you are the Holder of a Claim in Class 2 (Other Secured Claims) and Class 4 (General Unsecured Claims) entitled to vote on the Plan *and* any of the following scenarios applies to you: **(a)** you have voted to **ACCEPT** the Plan, did not opt-out of the Third-Party Release, and now wish to opt-out of the Third-Party Release; **(b)** you voted to **REJECT** the Plan, and now wish to change your vote to ACCEPT the Plan, while also opting-out of the Third-Party Release; or **(c)** you **DID NOT VOTE** on the Plan and now wish to vote to ACCEPT the Plan, while also opting-out of the Third-Party Release.

6. Upon request, the Balloting Agent will provide Holders of Class 2 Claims (Other Secured Claims) and Class 4 Claims (General Unsecured Claims) entitled to vote on the Plan with a corrected Ballot for their Class ("Corrected Ballot"), which such Holders may then complete and return to the Balloting Agent in accordance with the instructions to be provided. The Corrected Ballot must be properly completed and received by the Balloting Agent by **Wednesday, November 4, 2020, at 4:00 p.m. (ET)**.
