Tuesday Morning Corporation and its debtor affiliates, as debtors and debtors-in-possession in the above-referenced chapter 11 cases (collectively, the "Debtors") hereby file this Debtors' Expedited Motion for Entry of an Order Pursuant to 11 U.S.C. § 365(d)(4)(B)(ii) Extending the Debtors' Time to Assume or Reject Unexpired Leases of Non-Residential Real Property (the "Motion"). In support of the Motion, the Debtors respectfully state as follows:

#### **Jurisdiction and Venue**

1. The United States District Court for the Northern District of Texas (the "District Court") has jurisdiction over the subject matter of this Motion pursuant to 28 U.S.C. § 1334. The District Court's jurisdiction has been referred to this Court pursuant to 28 U.S.C. § 157 and the District Court's Miscellaneous Order No. 33, *Order of Reference of Bankruptcy Cases and Proceedings Nunc Pro Tunc* dated August 3, 1984. This is a core matter pursuant to 28 U.S.C. § 157(b), which may be heard and finally determined by this Court. Venue is proper pursuant to 28 U.S.C. §§ 1408 and 1409.

#### **Background**

- 2. On May 27, 2020 (the "Petition Date"), the Debtors each filed voluntary petitions for relief under chapter 11 of title 11 of the United States Code (the "Bankruptcy Code") commencing the above captioned jointly administered cases (the "Chapter 11 Cases"). The Debtors continue to manage and operate their businesses as debtors-in-possession pursuant to Bankruptcy Code §§ 1107 and 1108.
- 3. An official committee of unsecured creditors (the "<u>Creditors' Committee</u>") was appointed in these Chapter 11 Cases on June 9, 2020. An official committee of equity holders (the "<u>Equity Committee</u>") was appointed in these Chapter 11 Cases on October 5, 2020. No trustee or examiner has been requested or appointed in these Chapter 11 Cases.

- 4. A detailed description of the Debtors and their businesses are set forth in greater detail in the *Declaration of Barry Folse in Support of the Debtors' Chapter 11 Petitions and First Day Motions* (the "Folse Declaration"), which was filed on the Petition Date and is incorporated by reference in this Motion.
- 5. On the Petition Date, the Debtors are party to over 680 leases of nonresidential real property (the "Leases") located throughout the United States. The Debtors' Leases largely relate to the Debtors' brick and mortar retail stores (the "Stores"). On July 8, 2020, the Debtors filed the Debtors' Motion for Entry of an Order Pursuant to 11 U.S.C. § 365(d)(4) Extending the Debtors' Time to Assume or Reject Unexpired Leases of Non-Residential Real Property [Docket No. 414] (the "Extension Motion). On August 5, 2020, the Court entered an order granting the Extension Motion [Docket No. 559], which extended the deadline for the Debtors to assume or reject non-residential real property leases until December 23, 2020, or the date of entry of an order confirming a plan of reorganization or liquidation (the "Assumption/Rejection Deadline").
- 6. On November 15, 2020, the Debtors filed the *Motion for Entry of an Order Authorizing the Debtors to Pay the Extension Fee in Connection with the Extension of the ABL Expiration Date* [Docket No. 1586] (the "Extension Fee Motion"), which is set for hearing on November 23, 2020 at 10:30 a.m. Central Time. As set forth in the Extension Fee Motion, the ABL DIP Agent<sup>2</sup> has agreed to extend the November 25, 2020 expiration date of the ABL DIP (the "ABL DIP Expiration Date") from November 25, 2020 to January 21, 2020 (the "Extended Expiration Date") if certain conditions are met. One of the conditions for the Extended Expiration Date is that the Debtors obtain Court approval of an extension of the Assumption/Rejection

Deadline based on prior written consent of certain landlords. Thus far, the Debtors have obtained consent from approximately 329 landlords (the "Consenting Landlords") for an extension of the Assumption/Rejection Deadline for the relevant Stores to January 31, 2020, which forms the bases for this Motion.

#### **Relief Requested**

7. Pursuant to Bankruptcy Code § 365(d)(4)(B)(ii), the Debtors seek entry of an order, substantially in the form attached hereto as **Exhibit A** (the "Order"), extending the Assumption/Rejection Deadline for the Store Leases owned by the Consenting Landlords to January 31, 2020. If needed, the Debtors will provide copies of all 329 extension agreements. In lieu of such a voluminous exhibit, a form of the extension agreement (the "Extension Agreement") is attached to the Order as **Exhibit 1**. A schedule of the Consenting Landlords and their respective Store leases is attached to the Order as **Exhibit 2**. The Debtors respectfully request authority, but not direction, to enter into additional Extension Agreements with the remaining Landlords and file a notice of revised Exhibit 2 without the need for another Motion and hearing.

#### **Basis for Relief Requested**

- 8. Bankruptcy Code § 365(d)(B)(ii) provides that if a court grants the 210-day extension, the court may "grant a subsequent extension only upon prior written consent of the lessor in each instance." 11 U.S.C. § 365(d)(4)(B)(ii).
- 9. The Debtors' successful emergence from Chapter 11 requires a careful analysis of the Store Leases to determine if each fit within the Debtors' go-forward business strategy. The Debtors conducted store closing sales during May 2020 August 2020 and have rejected over 200 unprofitable Store leases.

- 10. While the Debtors have made substantial progress in the analysis of their Leases, the Debtors anticipate that this analysis will take additional time to complete. The Leases are a critical component of the Debtors' business that allow the Debtors to continue their business operations during and after the restructuring contemplated in these Chapter 11 Cases. Accordingly, the Debtors sent correspondence to all of its landlords requesting entry into the Extension Agreements. As noted above, approximately 329 landlords have signed Extension Agreements extending the Assumption/Rejection Deadline for their respective Leases to January 31, 2020.
- 11. The extension is appropriate given that the Consenting Landlords signed the Extension Agreement and agreed to the terms therein. Moreover, the Debtors are current on their postpetition obligations under § 365(d)(3) and are committed to remaining current on all such undisputed postpetition obligations. Should the Debtors ultimately decide to reject any of the remaining Leases, nothing will prejudice the rights of the affected Landlords to assert rejection damage claims as provided for in the Bankruptcy Code.
- 12. For the reasons set forth in this Motion, the Debtors respectfully submit that an extension of the Assumption/Rejection Deadline with respect to each of the Consenting Landlords' Leases is consensual, necessary, and is in the best interest of the Debtors, their estates, their creditors, and all parties in interest.

#### **Notice**

13. Notice of this Motion will be provided to: (i) the Office of the United States Trustee; (ii) the Debtors' secured creditors; (iii) all parties to the Leases, including but not limited to the Consenting Landlords of the Stores and their counsel of record, where applicable; (iv) those persons who have formally appeared and requested notice and service in these proceedings

pursuant to Bankruptcy Rules 2002 and 3017; (v) counsel for the DIP Agent; (vi) counsel for the Creditors' Committee and the Equity Committee; (vii) the list of the 20 largest unsecured creditors of each of the Debtors; and (viii) all governmental agencies having a regulatory or statutory interest in these cases (collectively, the "Notice Parties"). Based on the nature of the relief requested herein, the Debtors respectfully submit that no further notice is required.

WHEREFORE, the Debtors respectfully request that the Court (i) grant the Motion and (ii) grant such other and further relief as is just and proper.

Upon entry into additional Extension Agreements, the Debtors shall file and cause to be served a notice of revised Exhibit 2 to this Order reflecting such Consenting Landlord extensions and the related Store Leases.

Dear Sir/Madam:

As you are aware, on May 27, 2020, Tuesday Morning Corporation and its affiliated debtors (the "<u>Debtors</u>"), including Tuesday Morning Inc. ("<u>Tenant</u>"), commenced cases under chapter 11 of title 11 of the United States Code (the "<u>Bankruptcy Code</u>"). The chapter 11 cases are currently proceeding before Judge Harlin D. Hale in the United States Bankruptcy Court for the Northern District of Texas, Dallas Division (the "Bankruptcy Court").

The current deadline for Tenant to assume non-residential real property leases is December 23, 2020 (the "Lease Assumption Deadline"). Pursuant to Bankruptcy Code § 365(d)(4), the current lease assumption deadline cannot be extended without the prior written consent of the applicable landlord.

Tenant is party to a lease agreement (the "<u>Lease</u>") with the undersigned landlord ("<u>Landlord</u>") pursuant to which Tenant is currently leasing the premises located at the store address identified on the signature page below. On September 23, 2020, the Debtors filed a proposed plan of reorganization, disclosure statement, and motion to approve bidding procedures in the Bankruptcy Court. The undersigned parties hereby acknowledge their authority to sign this letter agreement, and acknowledge that this agreement constitutes "prior written consent of the lessor," as required by Bankruptcy Code § 365(d)(4), and that no further consent of the Landlord shall be required for the sole purpose of extending the time within which the Debtors must assume or reject the Lease through and including January 31, 2021. This letter agreement is entered into by both parties with a full reservation of rights and does not constitute an agreement by the Debtors to assume the Lease nor does it constitute an agreement by the Landlord to consent to the assumption or assumption and assignment of the Lease. For the avoidance of doubt, the sole purpose of this letter agreement is to grant an extension of the Lease Assumption Deadline and the letter does not effect an amendment of the Lease nor does it waive any rights of either party under the Lease and each of the parties' respective rights under the Lease are fully preserved.
