- 1. The above-captioned debtors and debtors-in-possession (collectively, the "<u>Debtors</u>"), seek to sell substantially all of their assets (the "<u>Acquired Assets</u>")<sup>2</sup> free and clear of certain liens, claims, and encumbrances pursuant to their Motion for Entry of Order (A) Approving the Sale of the Debtors' Assets Free and Clear of All Liens, Claims, Encumbrances, and Other Interests, and (B) Authorizing the Assumption and Assignment of Certain Executory Contracts and Unexpired Leases [Doc. No. 408] (the "Sale Motion") filed on August 28, 2020.
- 2. On September 8, 2020, the Court entered its Order (I) Approving Auction and Bidding Procedures in Connection with the Sale of Substantially All of the Debtors' Assets, (II) Permitting Debtors to Designate Stalking Horse Purchaser and Grant Bid Protections, (III) Approving Procedures Related to the Assumption and Assignment of Executory Contracts and Unexpired Leases, (IV) Scheduling Auction and Sale Hearing, (V) Approving the Form and Manner of Sale Notice, and (VI) Granting Related Relief [Doc. No. 445] (the "Bidding Procedures Order").
- 3. The Debtors previously set forth the Cure Amount for executory contracts and unexpired leases on the Assignment Schedule attached to the Notice of Potential Assumption and Assignment of Certain Executory Contracts and Unexpired Leases ("<u>Cure Notice</u>"). On October 9, 2020, the Debtor filed a Supplemental Cure Notice (<u>1</u><sup>st</sup> Supplemental Cure Notice).

On October 19, 2020, the Debtor filed a Supplemental Cure Notice ( $2^{nd}$  Supplemental Cure Notice).

- 4. Pursuant to the Bidding Procedures Notice, the Debtors reserved the right to add or delete an executory contract or unexpired lease to the Assignment Schedule or modify the cure amount by filing and serving a separate supplemental cure notice.
- 5. An Assignment Schedule showing specific additions, deletions, and modifications to the prior Cure Notice,  $1^{st}$  Supplemental Cure Notice and  $2^{nd}$  Supplemental Cure Notice is attached as **Exhibit A** to this Third Supplemental Cure Notice. Bedenbaugh and Rebecca Finch Redwine, Hendren, Redwine & Malone, PLLC, 4600 Marriott Drive, Suite 150, Raleigh, NC 27612; (ii) counsel to the Committee; (iii) counsel to any proposed Stalking Horse Purchaser; and (iv) the Office of the Bankruptcy Administrator for the Middle District of North Carolina (the "Contract Notice Parties"), so as to be actually received within ten (10) days after service of the Third Supplemental Cure Notice (the "Cure Objection Deadline").
- 7. Any other objection to the assumption and assignment of any Designated Contract identified on the Third Supplemental Cure Notice (aside from an objection to the Cure Amount), including with respect to an objection on the basis of adequate assurance of future performance by a Successful Bidder shall be filed and served on the Contract Notice Parties, as well as counsel for the Successful Bidder, so as to be <u>actually received</u> within ten (10) days after service of the Third Supplemental Cure Notice
