**RECOMMENDATION OF THE OFFICIAL COMMITTEE OF UNSECURED
CREDITORS TO ACCEPT THE DEBTORS' FIRST AMENDED
JOINT CHAPTER 11 PLAN**

To: All Holders of Claims (“Voting Creditors”) Entitled to Vote on the Amended Joint Chapter 11 Plan of Liquidation of Permian Holdco 1, Inc., *et al.*

Re: **In re Permian Holdco, Inc., et al., Case No. 20-11822 (MFW)**

Dear Voting Creditors:

The Official Committee of Unsecured Creditors (the “Official Committee”) of Permian Holdco 1, Inc., Permian Holdco 2, Inc., Permian Holdco 3, Inc. and Permian Tank & Manufacturing, Inc. (collectively, the “Debtors”) submits this letter to all creditors entitled to vote on the Amended Joint Chapter 11 Plan of Liquidation of the Debtors (as it may be altered, amended, modified or supplemented from time to time including in accordance with its terms, any Plan Supplement, the Bankruptcy Code or the Bankruptcy Rules, the “Plan”).¹

The Official Committee recommends that creditors vote to **ACCEPT** the Plan. **(Please note: This letter is sent solely by the Official Committee and has not been approved by the Bankruptcy Court.)**

As discussed in the Debtors’ Amended Combined Disclosure Statement and Plan, on July 19, 2020 (the “Petition Date”), the Debtors filed voluntary petitions for relief under chapter 11 of the Bankruptcy Code in the United States Bankruptcy Court for the District of Delaware. The bankruptcy cases are pending before the Honorable Mary F. Walrath.

The Office of the United States Trustee appointed the Official Committee on July 28, 2020. The Official Committee selected Troutman Pepper Hamilton Sanders LLP to serve as its legal counsel. The Official Committee represents the interests of the Debtors’ general unsecured creditors. The Official Committee writes regarding the solicitation of ballots to accept or reject the Plan, which you are receiving from the Debtors in the same package as this letter.²

The Official Committee’s purpose includes, among other things, maximizing recoveries for holders of general unsecured claims in light of relevant risks, ensuring fairness to unsecured creditors in the chapter 11 processes employed by the Debtors and other interested parties, and facilitating the liquidation of the Debtors on terms that are fair and equitable.

The Official Committee’s decision to support the Plan was made after carefully considering several factors, including, among other things, the estimated distribution to creditors. The Plan contemplates that a post-confirmation trustee will pursue litigation claims that constitute the collateral of the Debtors’ secured creditor. Under the terms of the Plan, including the settlements

contained therein, the secured lender agreed to provide financing for the litigation and to share the proceeds of the litigation claims, if any, for the benefit of holders of general unsecured claims. Absent approval of the Plan, and the settlements contained therein, those litigation proceeds would likely not be available to general unsecured creditors.

The Plan also provides for the waiver of certain note claims against Permian Holdco 2, Inc. and Permian Holdco 3, Inc., and the subordination of a substantial general unsecured claim against Permian Tank & Manufacturing, Inc. These waivers and subordination may create a greater recovery for the other general unsecured creditors of those Debtors by reducing the claims that will share pro rata in any litigation proceeds.

Section 14.1 of the Plan contains release, exculpation, and injunction provisions, and SECTION 14.1(c) OF THE PLAN CONTAINS THIRD-PARTY RELEASES. You are deemed to grant the third-party releases if you vote to accept or reject the Plan and do not opt-out of the releases.

The Official Committee conducted a thorough due diligence review of the release, exculpation, and injunction provisions contained in Section 14.1 of the Plan. Those provisions are integral to the settlements that form the basis for the potential distributions to general unsecured creditors under the Plan. Upon concluding its due diligence review, the Official Committee has determined that it is appropriate to support the Plan and to provide this letter in support of the Plan. The opinion of the Official Committee is that other alternatives, including protracted litigation, would involve significant risk, delay, uncertainty and additional administrative costs.³ Nevertheless, you should review carefully the provisions of Section 14.1.

The Official Committee recommends that you vote to ACCEPT the Plan. Notwithstanding this recommendation, you must make your own independent determination as to whether the Plan is acceptable to you and should consult your own legal and/or financial advisor(s).

The Official Committee urges all Voting Creditors, before voting, to read and review, carefully and in its entirety, the Amended Combined Disclosure Statement and Plan, including the discussion of the risk factors related to the Plan, and all other documents submitted to you by the Debtors. This communication does not constitute, and shall not be construed, as a recommendation or solicitation by any individual member of the Official Committee.

The Combined Disclosure Statement and Plan can be confirmed by the Bankruptcy Court and, thereby, made binding on you if it is accepted by the Holders of at least two-thirds in amount and more than one-half in number of the Claims in each Impaired Class who vote on the Combined Disclosure Statement and Plan and if the Combined Disclosure Statement and Plan otherwise satisfies the applicable requirements of Bankruptcy Code section 1129(a). If the requisite acceptances are not obtained, the Bankruptcy Court nonetheless may confirm the Combined Disclosure Statement and Plan if it finds that the Combined Disclosure Statement and Plan (i) provides fair and equitable treatment to, and does not unfairly discriminate against, the Class or Classes rejecting the Combined Disclosure Statement and Plan and (ii) otherwise satisfies the requirements of Bankruptcy Code section 1129(b).

If neither the “accept” nor “reject” box is checked or if both boxes are checked in Item 2 for an otherwise properly completed, executed, and timely returned Ballot, the Ballot will not be counted for voting purposes.

- If you voted to accept or reject the Combined Disclosure Statement and Plan, review the opt-out election disclosure in Item 3, and determine whether to opt out of the release provisions contained in Section 14.1(c) of the Combined Disclosure Statement and Plan by checking the box in Item 3. Electing to opt out of such release provisions by checking the box in Item 3 will result in you NOT being a Released Party.

As of the Effective Date, for good and valuable consideration, the adequacy of which is hereby confirmed, the Releasing Parties shall be deemed to forever release, waive and discharge the Third-Party Released Parties of all claims, obligations, suits, judgments, damages, demands, debts, rights, remedies, causes of action and liabilities of any nature whatsoever in connection with or related to the Debtors, their operations, their assets, the Estates, the Chapter 11 Cases, or the combined Disclosure Statement and Plan, whether liquidated or unliquidated, fixed or contingent, matured or unmatured, known or unknown, foreseen or unforeseen, then existing or hereafter arising, in law, equity, or otherwise that are or may be based in whole or in part upon any act, omission, transaction, event, or other occurrence taking place or existing on or prior to the Effective Date (other than the rights of Holders of Allowed Claims to enforce the obligations under the Confirmation Order and the Plan); provided, however, that nothing in this section shall operate as a release, waiver or discharge of any causes of action or liabilities unknown to such Entity as of the Petition Date arising out of gross negligence, willful misconduct, actual fraud, or criminal acts of any such Released Party as determined by a Final Order.

As defined in the Combined Disclosure Statement and Plan:

“Third-Party Released Parties” shall mean (i) the Debtors, (ii) the Committee, (iii) NMFC, in its capacity as Prepetition Lender, Prepetition Agent, Lender, DIP Agent, noteholder, and shareholder, (iv) SSIG, in its capacity as prepetition noteholder and shareholder, (v) Solace, in its capacity as prepetition noteholder and shareholder, (vi) any directors that are currently serving on the Debtors’ boards of directors, (vii) any directors that previously served on the Debtors’ boards of directors who were designees of NMFC or SSIG, or of their respective Affiliates, (viii) Santosh Rao and Rao Advisory, LLC, (ix) Chris Maier and CM Advisory, Inc., (x) Joshua Porter; (xi) the Debtors’ current officers, and (xii) with respect to each of the foregoing, their respective Related Parties; provided, however, that the Third-Party Released Parties shall not mean or include the Solace Defendants.

“Releasing Parties” shall mean (a) all Holders of Claims that are deemed to accept the Plan, (b) all Holders of Claims who vote to accept the Plan and who do not submit a Release Opt-Out Election, and (c) all Holders of Claims who vote to reject the Plan and who do not submit a Release Opt-Out Election.

“Release Opt-Out Election” shall mean the timely election of a Holder of a Class 3 Claim entitled to vote on the Plan to “opt out” of being a Releasing Party by submitting a Ballot by the Voting Deadline that (i) votes to accept or reject the Plan and (ii) selects the option set forth on the Ballot to not grant the releases set forth in Section 14.1(c) of this Plan.
